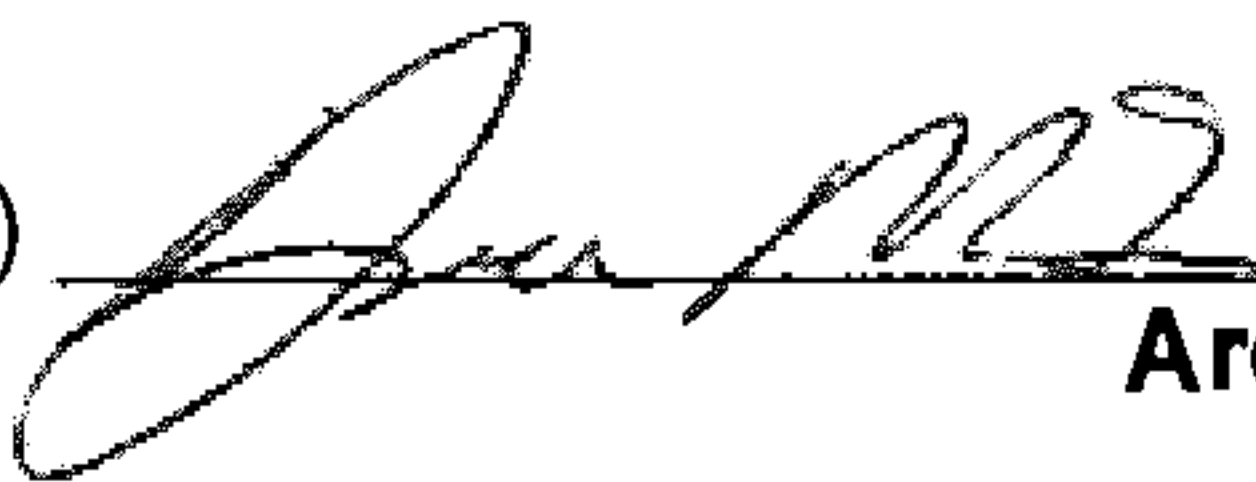
\$380,800.00 of the proceeds come from a mortgage recorded simultaneously herewith.

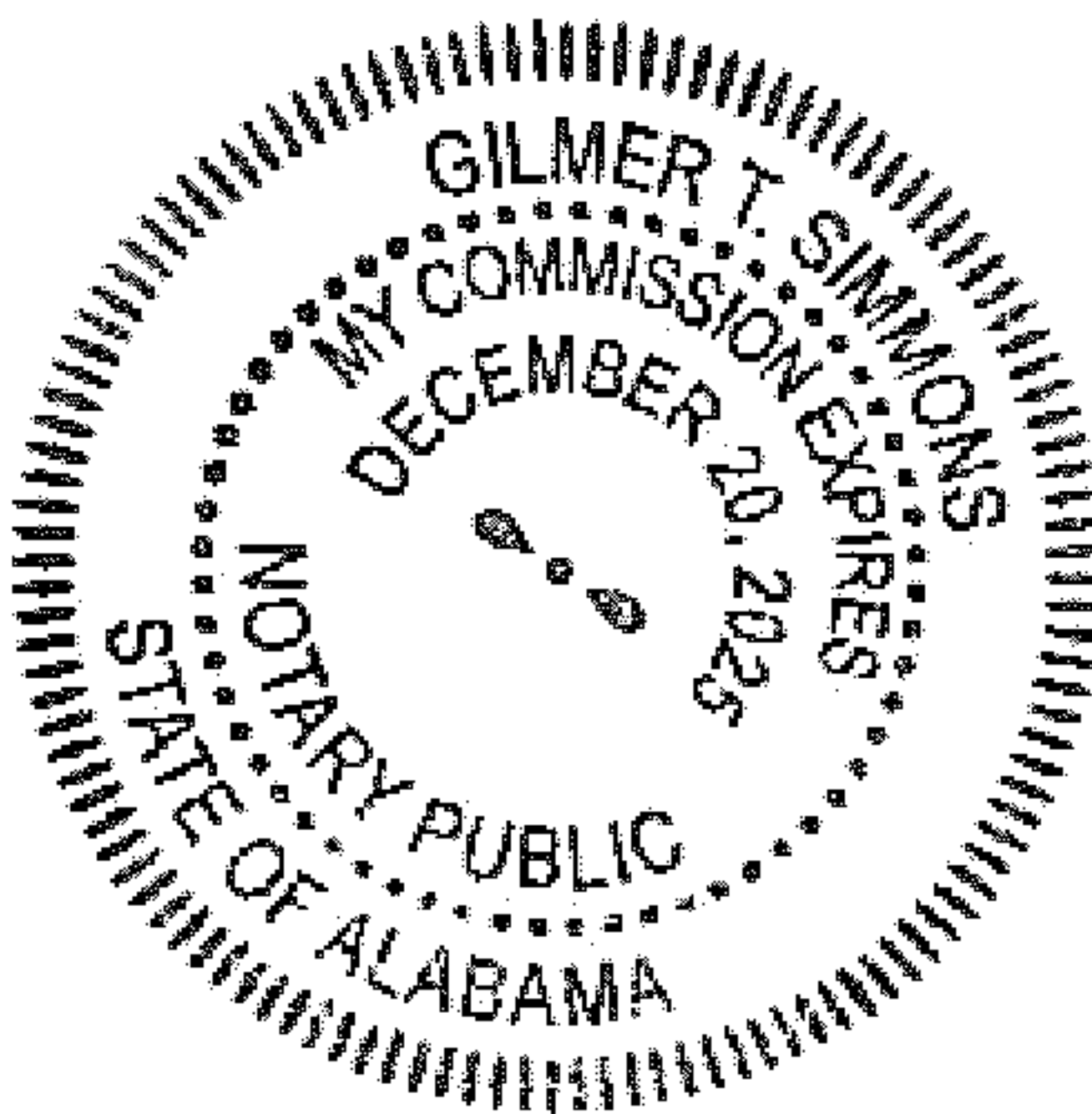

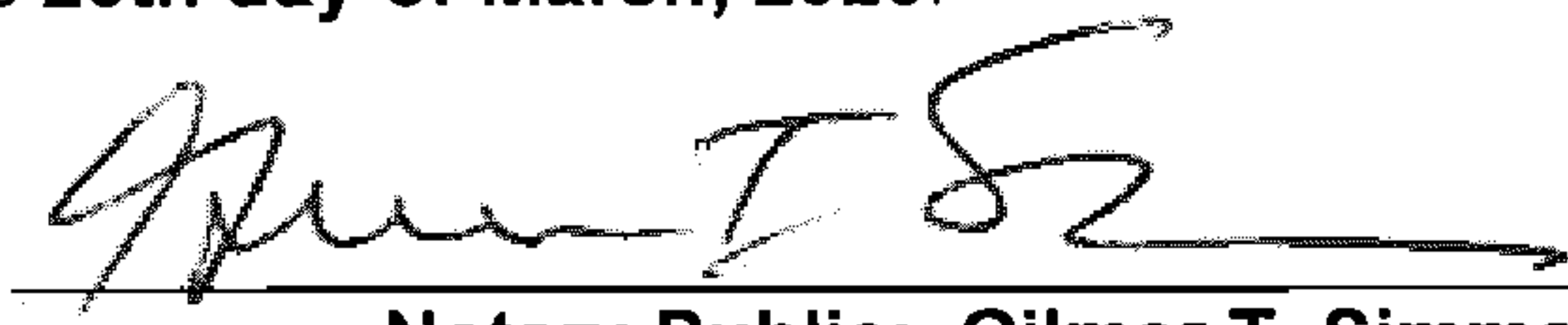
