Lots 5 and 6, in Block 72, as shown by Safford’s Map of Shelby, said property being situated in Shelby County, Alabama.

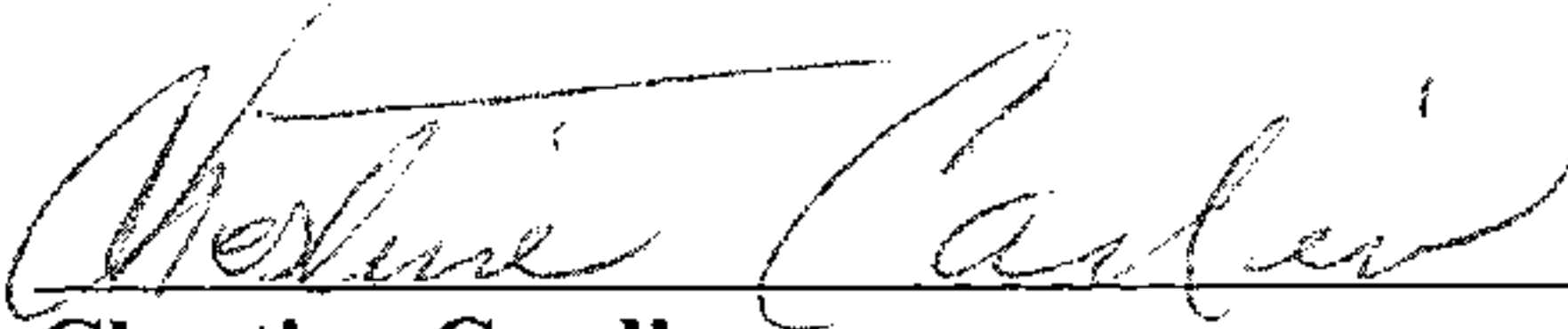
SUBJECT TO:

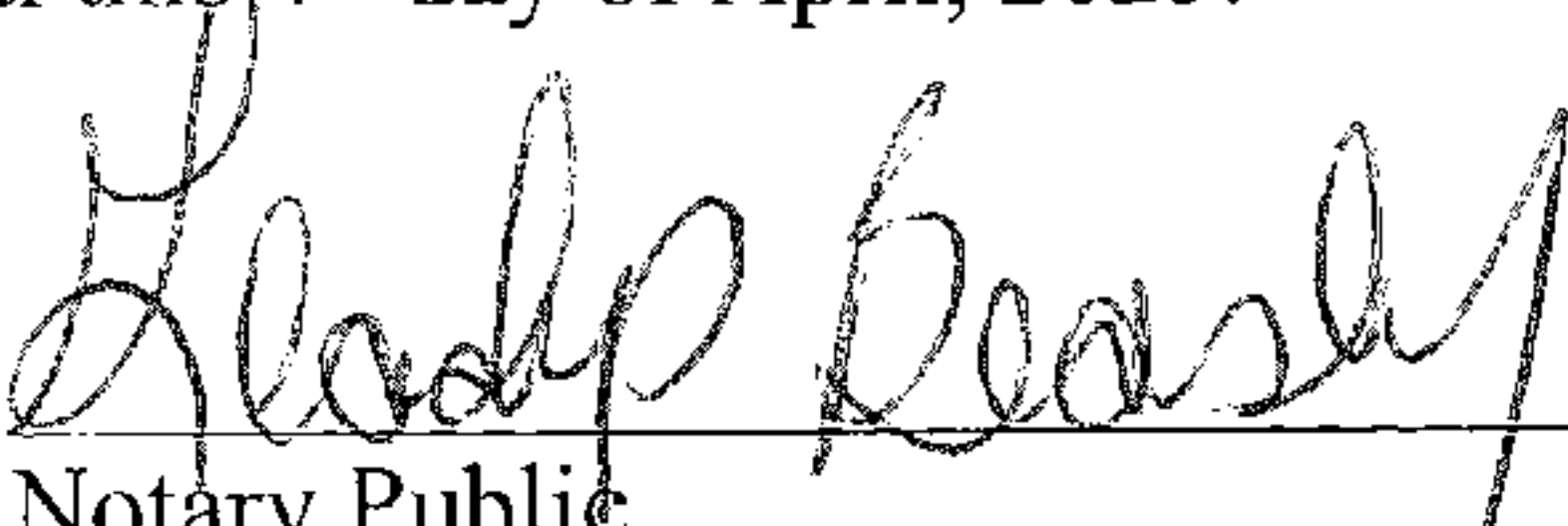

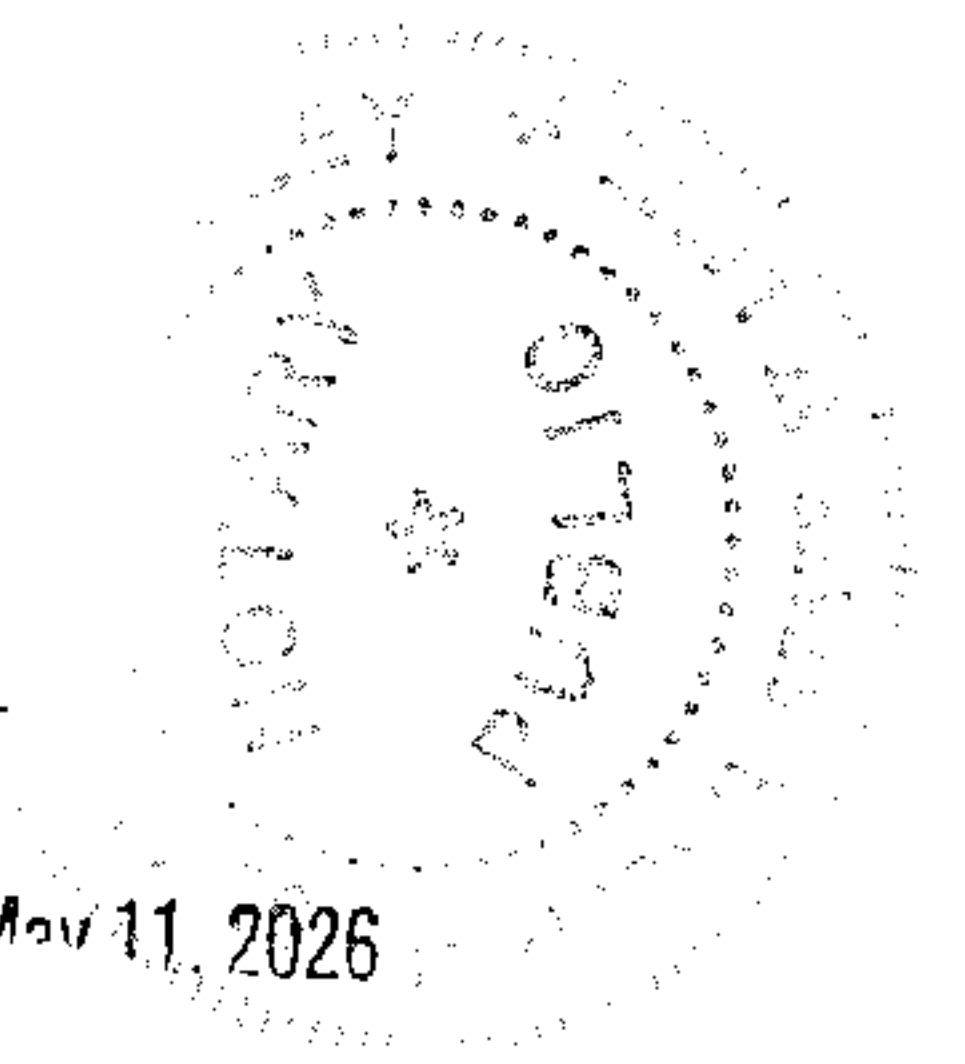
