**Lot 2, according to the Survey of Covington Place, as recorded Map Book 35, Page S5, in the Probate Office of Shelby County, Alabama.**



**\$283,500.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.**






