KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on to wit, November 12, 2021, Krista Angrisano, single, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for Guild Mortgage Company, LLC, which said mortgage was recorded in Instrument Number 20211118000556930 in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage subsequently transferred and assigned to Guild Mortgage Company LLC by instrument recorded in Instrument Number 20231012000302700 in the aforesaid Probate Office (hereafter "Transferee"); and

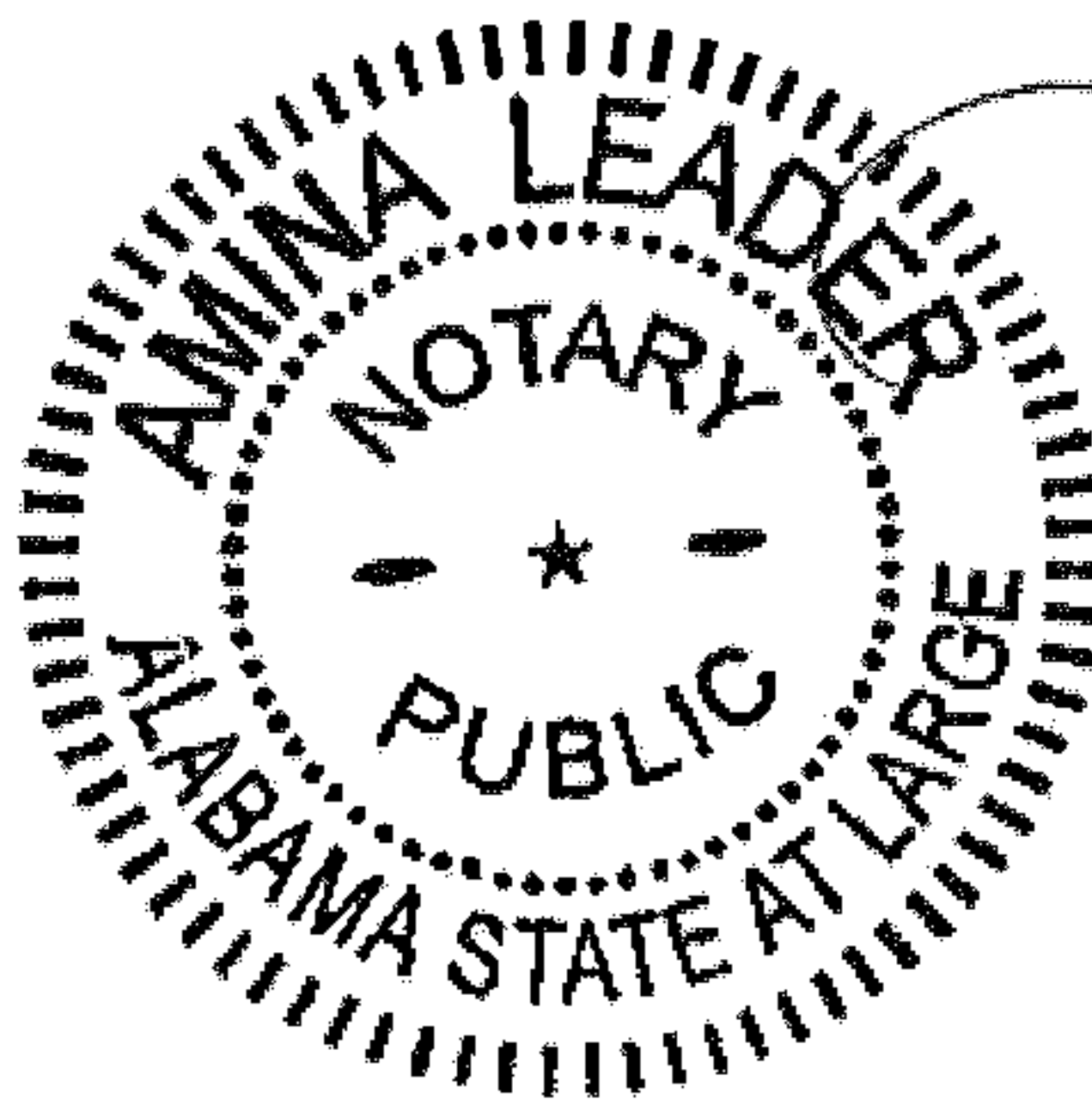
