(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Amber Martin Hagood and Danny W. Hagood, Jr.

(hereinafter referred to as "Grantees"), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:




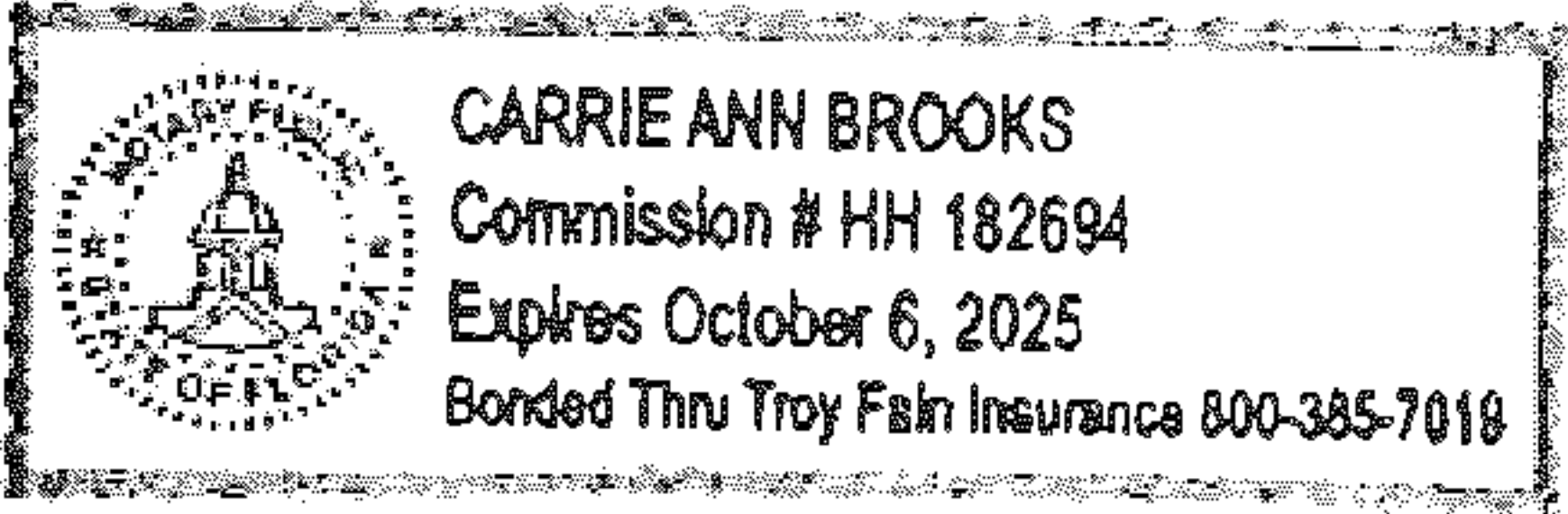
