} Know All Men by These Presents:

County of Shelby

That in consideration of the sum of **Seventy Eight Thousand Dollars and No Cents (\$78,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Johnathon Bryan Draper and Jane Draper**, husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Westley Said and Maddie Said**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 2, according to the Survey of Cartville Estates as recorded in Map Book 56, Page 24, in the Probate Office of Shelby County, Alabama.

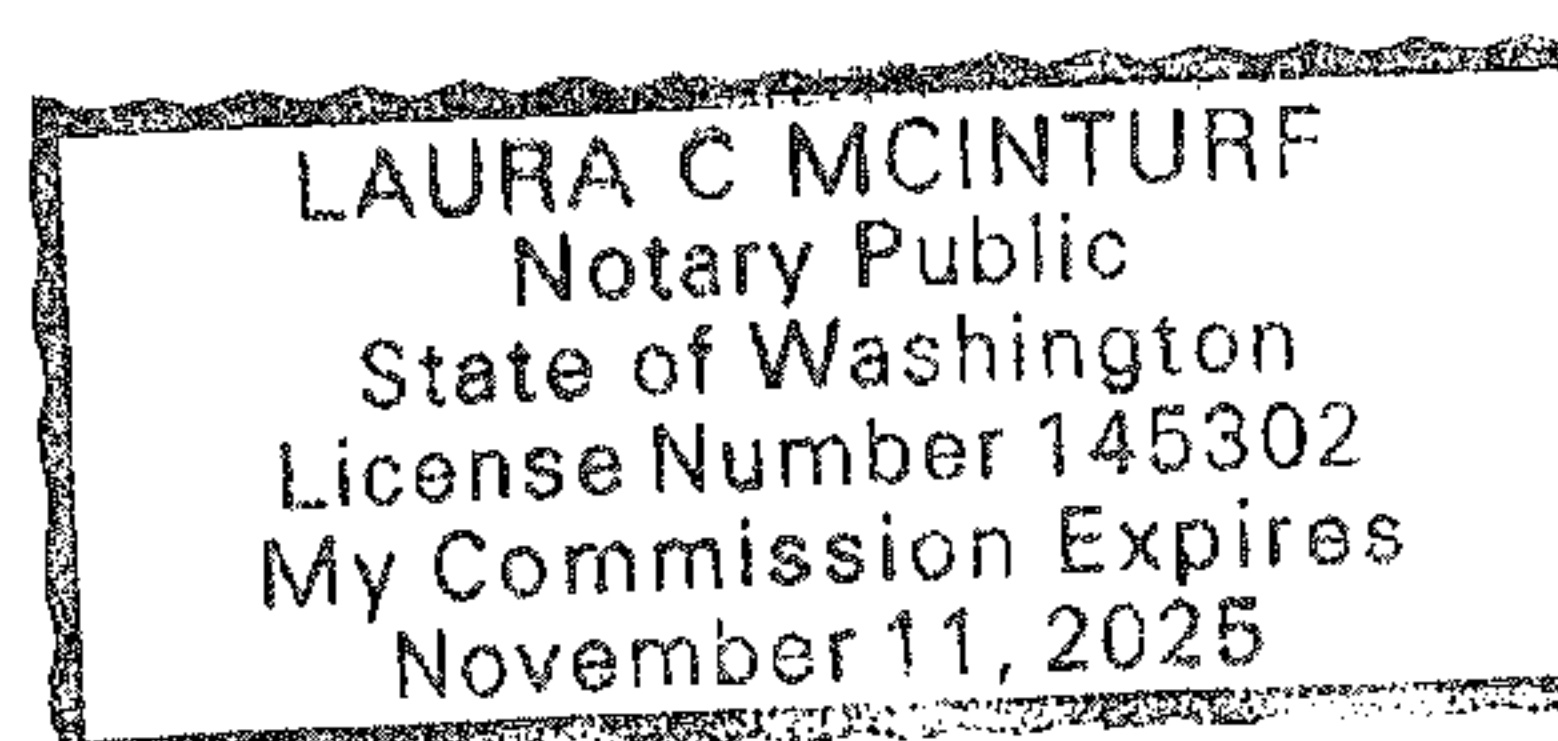
