KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: May 28, 2021, Jaime Felipe Reid, Jr. and Melanie R. Reid, husband and wife, ("Mortgagor(s)"), executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. solely as nominee for Caliber Home Loans, Inc. which said mortgage was recorded June 4, 2021 in Inst. 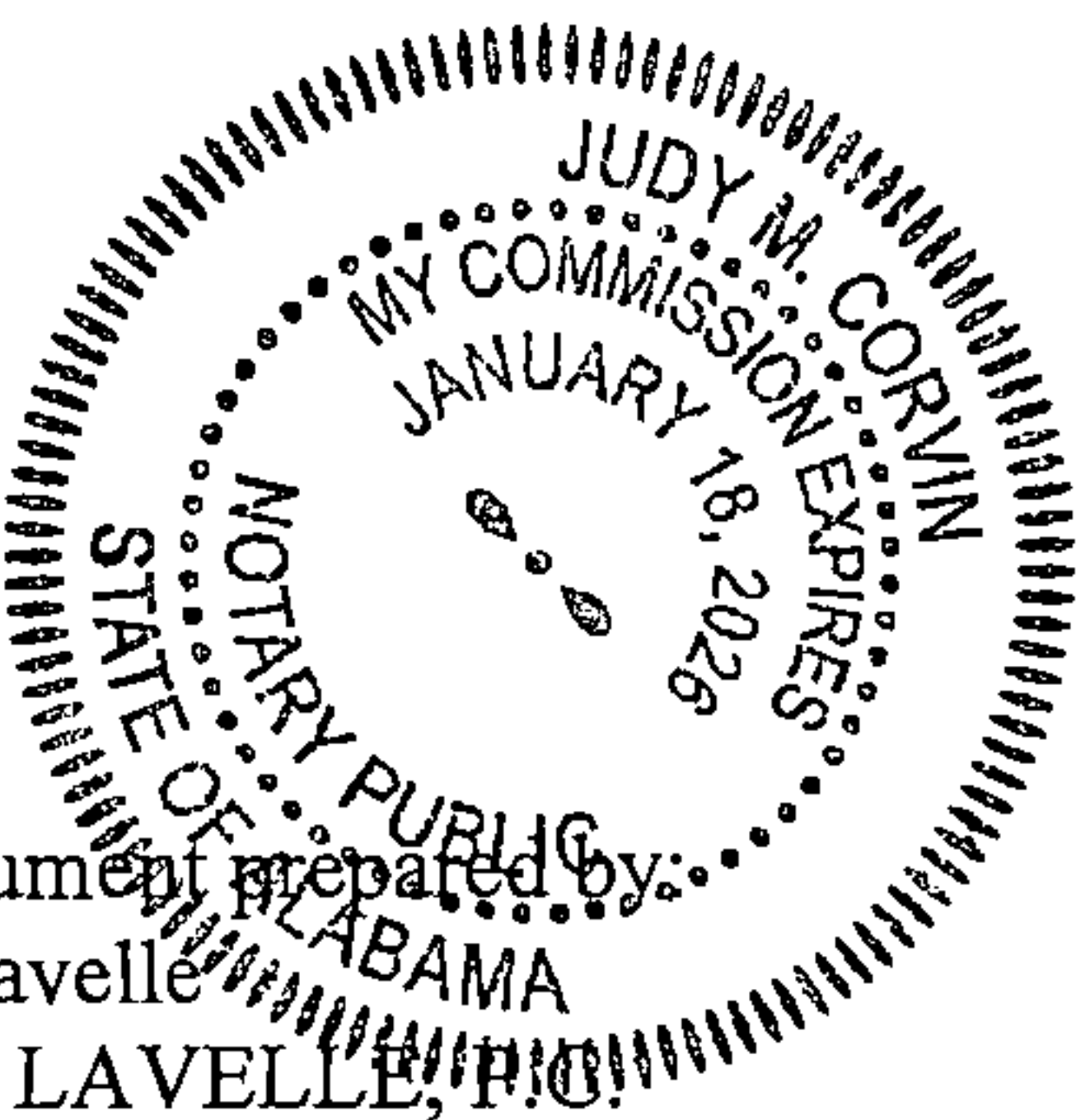
