- 2. Easements, restrictions, rights of way, and permits of record.

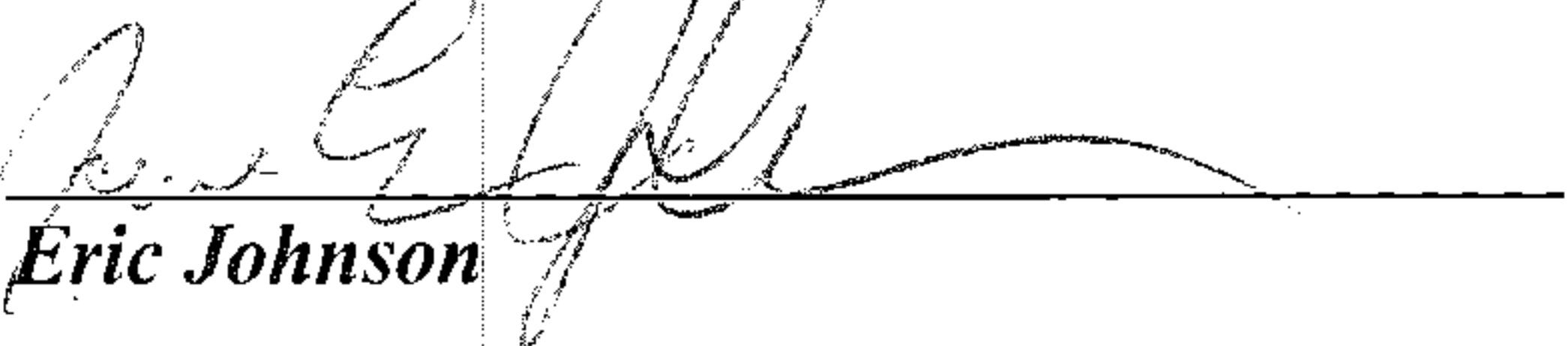
Grantors herein are all the surviving heirs at law of Mickey L. Johnson, having died on 2-21-25.

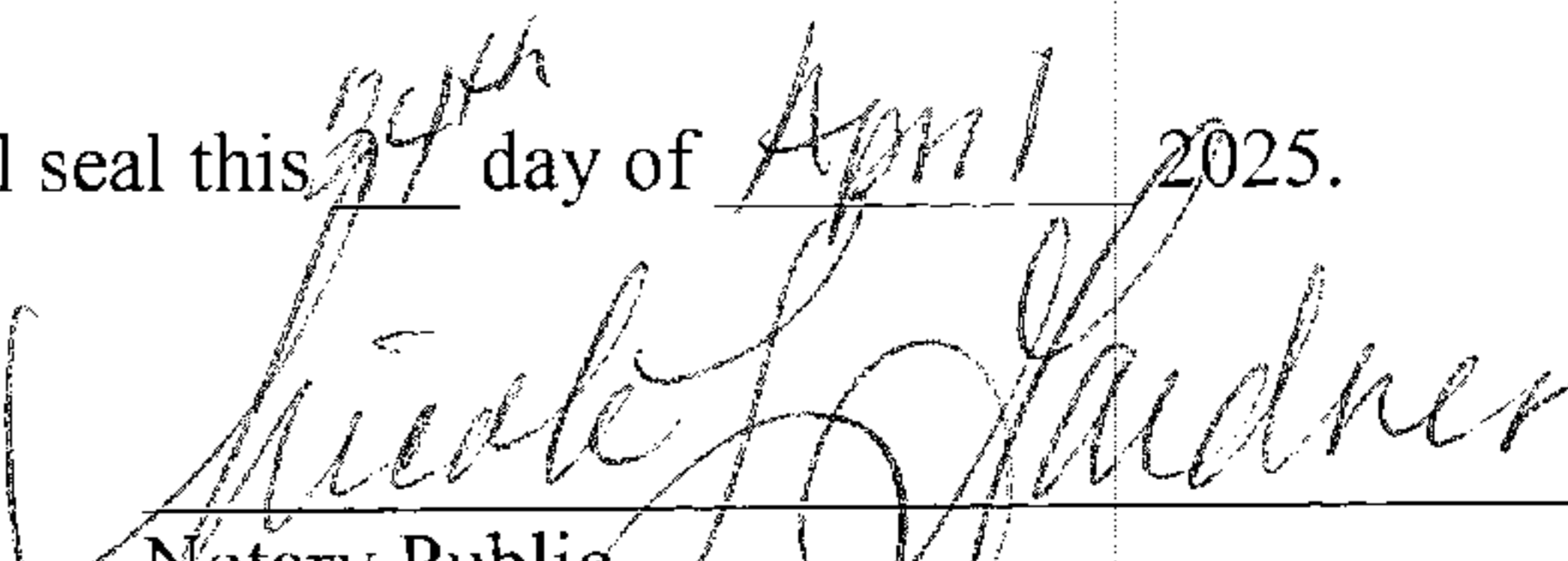

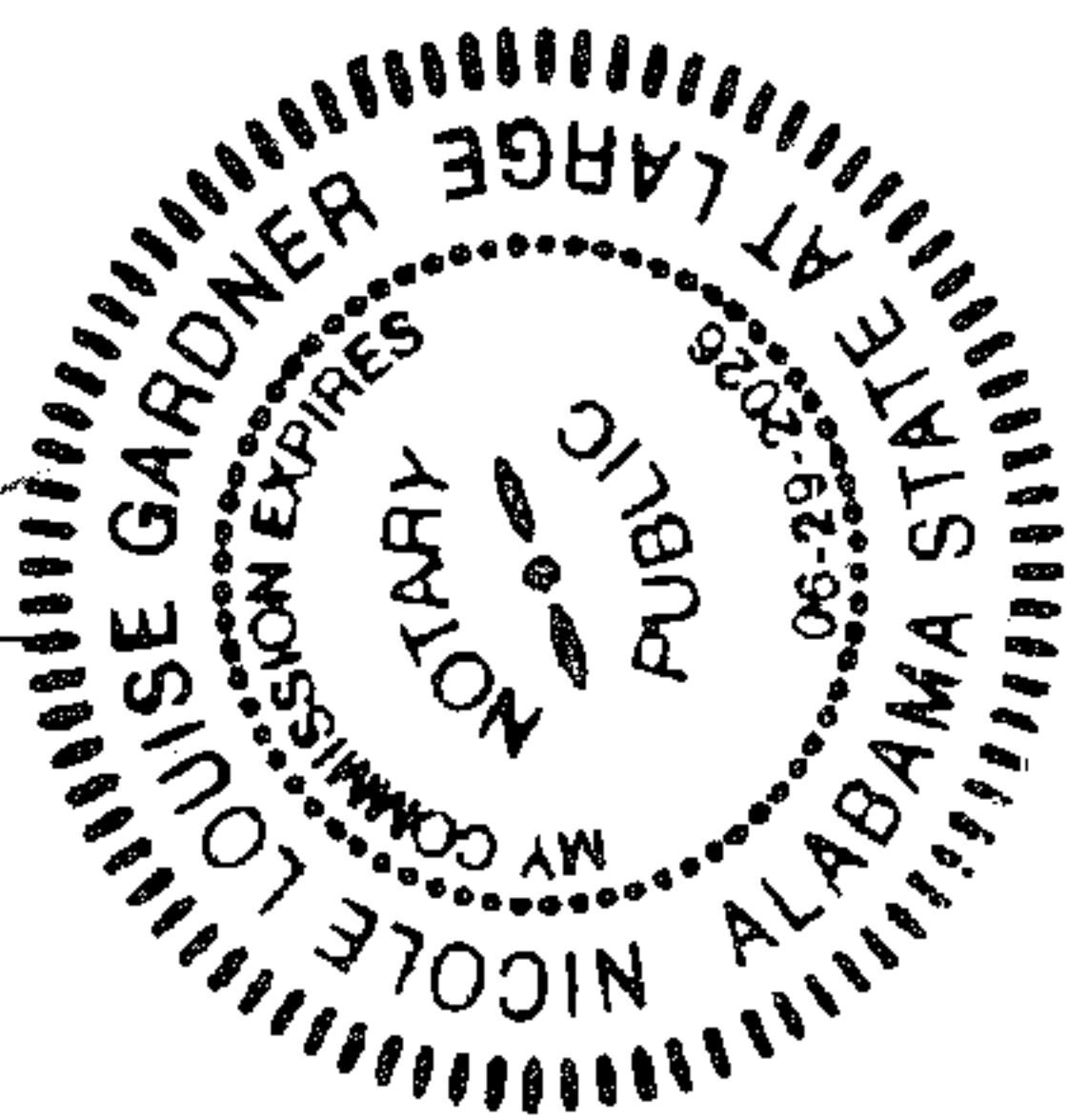
