in common, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY**

6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 50, Page 25.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.




