
Certification of Trust for the THE CLINE LIVING TRUST

To the best of the undersigned's knowledge the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect. There have been no amendments limiting the powers of our Trustees over trust property.
