KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of TWO HUNDRED NINETY-NINE THOUSAND NINE HUNDRED AND NO/100 DOLLARS (\$299,900.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **GRANT COX and NATALIE ROBINETTE COX, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ANDREW BOBBY EDWARDS and BRIANA EDWARDS** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 33, according to the Survey of Dearing Downs, Third Addition, as recorded in Map Book 87, Page 15, in the Office of the Judge of Probate of Shelby County, Alabama.

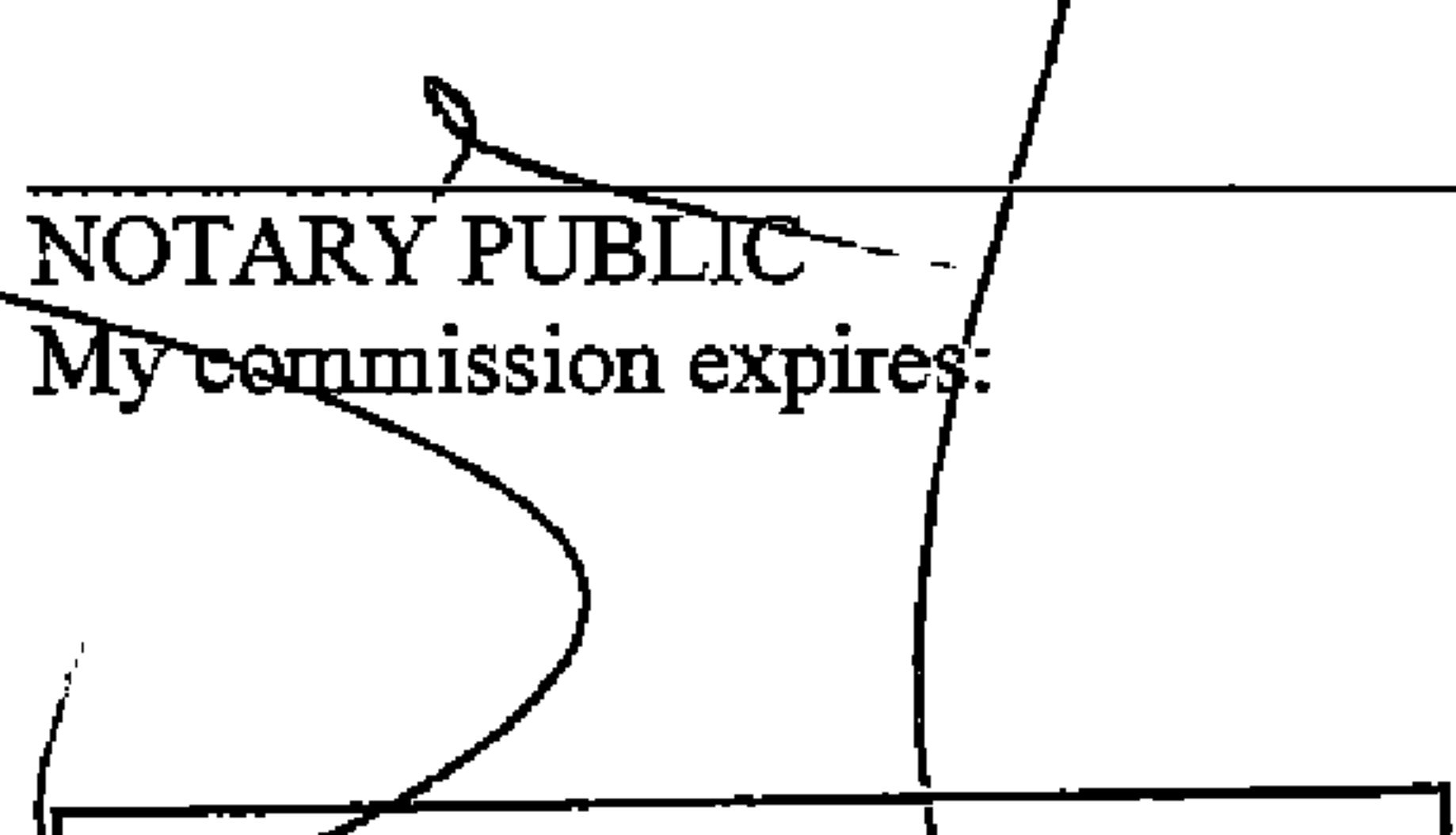

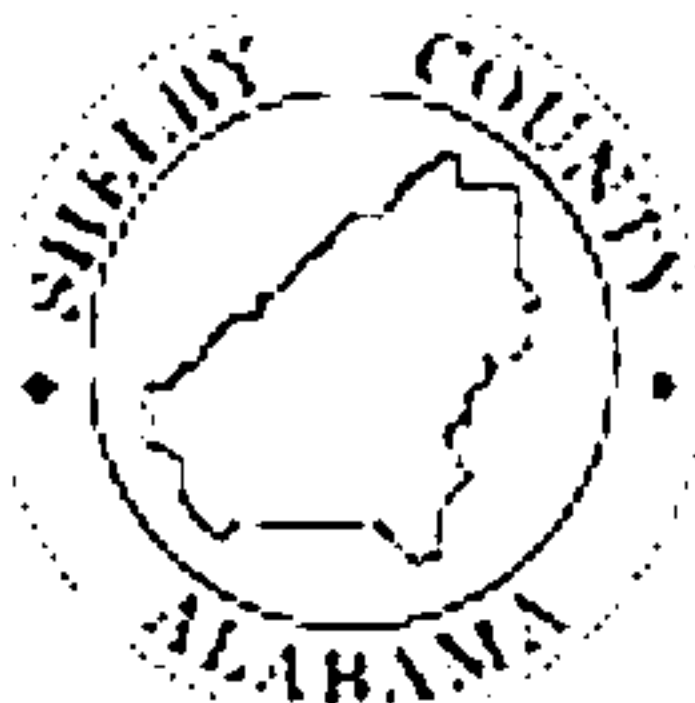
