Starling and Kayla Marie Purvis, a married couple** (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS hereby give, grant, bargain, sell and convey unto the GRANTEES, **Bryan Wolfe and Katherine Wolfe** (hereinafter referred to as GRANTEES), their successors and assigns, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Kayla Purvis Starling is one and the same person as Kayla Marie Purvis, grantee of the deed recorded in Instrument #20230320000074940.






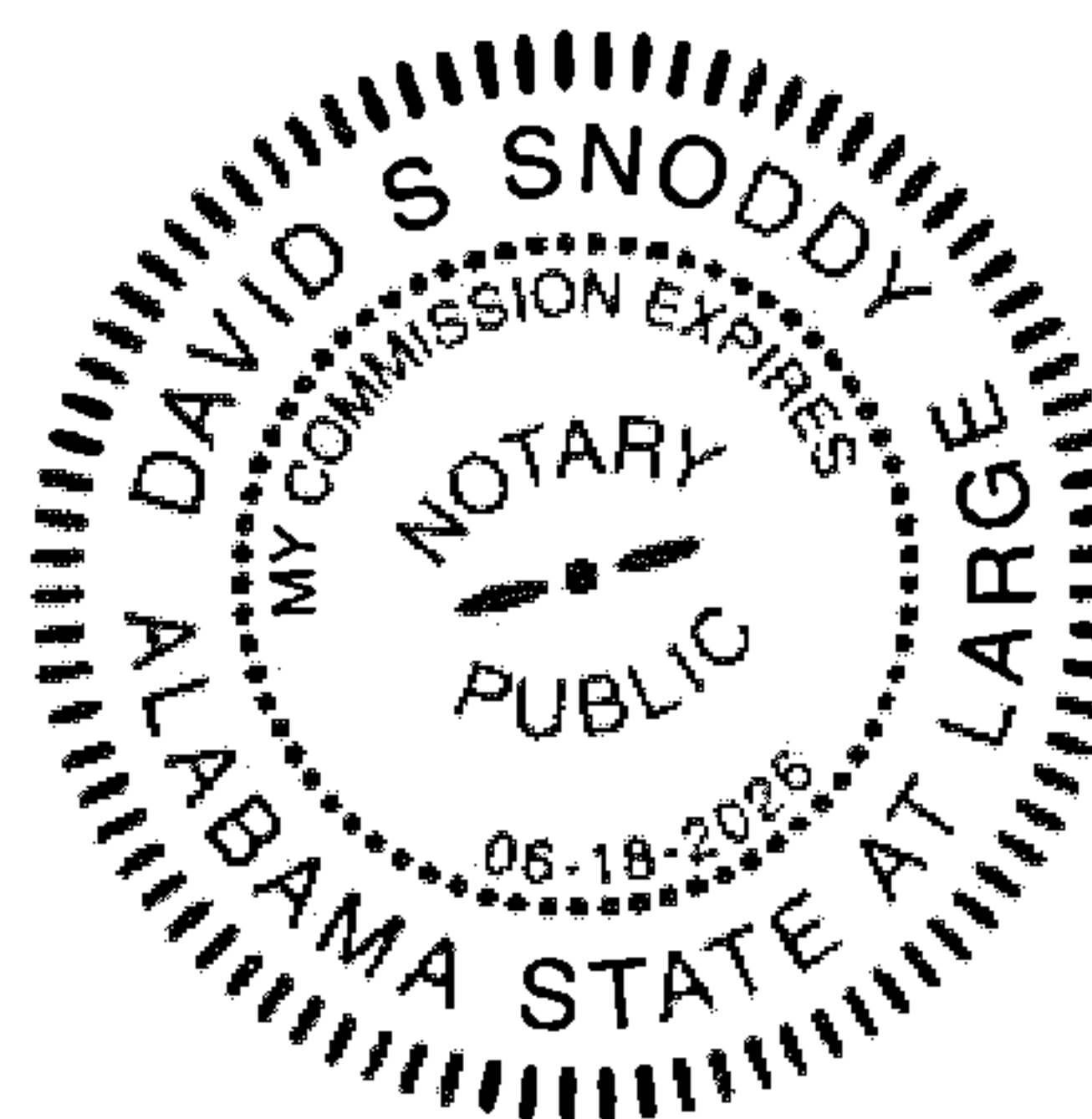
