**WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**  
**STATE OF ALABAMA**

That in consideration of **FOUR HUNDRED SIXTY THOUSAND AND 00/100 Dollars (\$460,000.00)** to the undersigned grantors in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

**Jervis D. Payne and Sarah Lynn Scheurich-Payne, a married couple**

(hereinafter referred to as “Grantors”) do grant, bargain, sell and convey unto

**Garrick Moultrie and Morgan Lott Moultrie**

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

**Lot 114, according to the Map and Survey of Southern Pines, Fourth Sector, in Map Book 7, Page 68 in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama**


**\$312,000.00** of the proceeds come from a mortgage recorded simultaneously herewith.

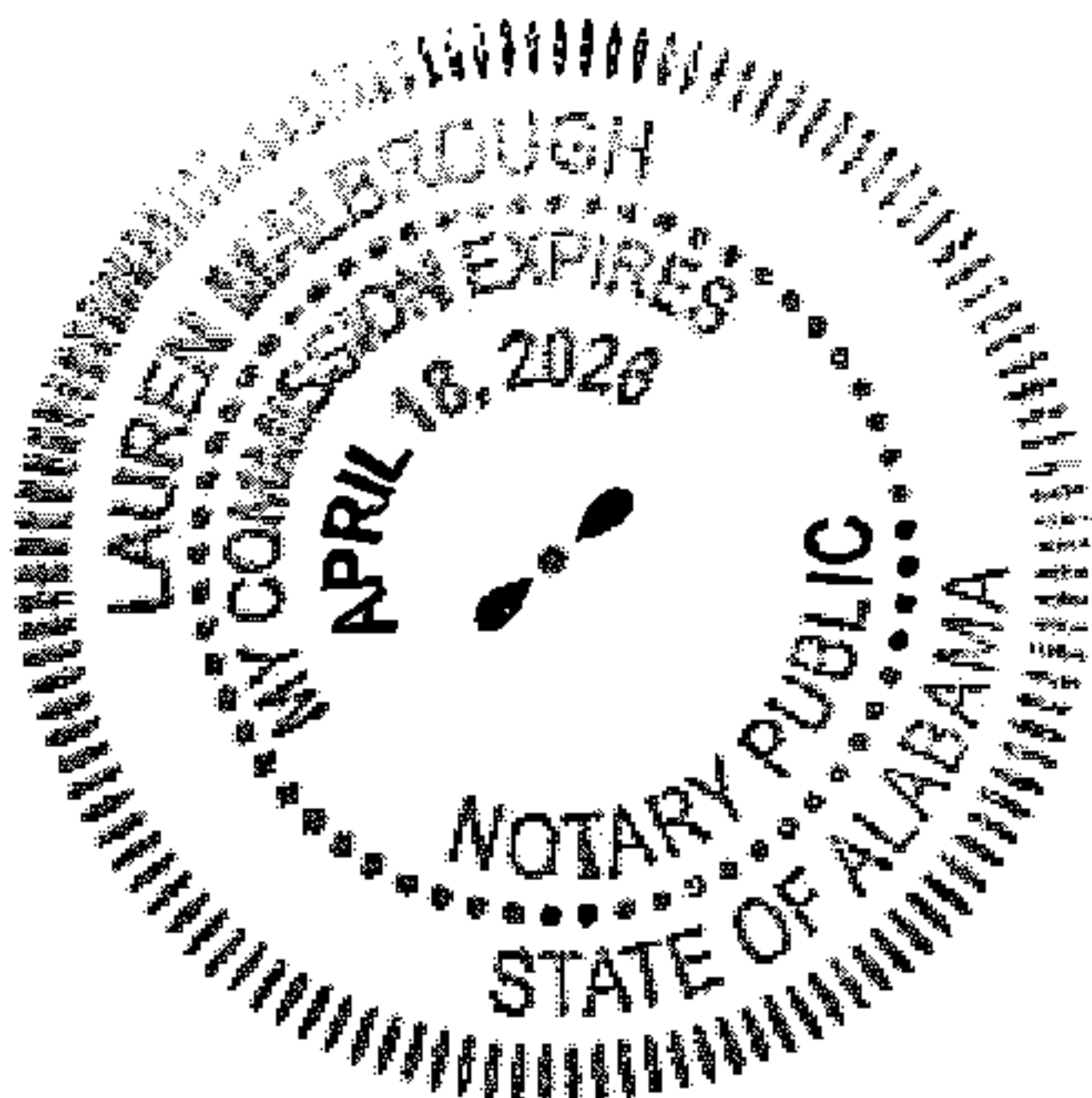
