Bostrom and wife, Katherine T. Bostrom**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **James H. Kervin II and Leigh P. Kervin**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

**\$416,137.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.**


