5. The provisions of the trust relating to the succession of Trustees of the trust read as follows:

Upon the death, resignation or inability of the Trustor to serve as Trustee, the following persons, in succession, shall serve as Trustee in that person's stead, so that if the first named is or becomes unable or elects not to so serve, the next named person or institution shall serve:

LUKE GERARD KREIZINGER and CLAIRE KREIZINGER CHANDLER, the Trustor's children, as Co-Trustees. If either LUKE GERARD KREIZINGER or CLAIRE KREIZINGER CHANDLER is unable or unwilling to so serve, the other shall serve as sole Trustee.

DANIEL S. MODAFFERI, the Trustor's friend.

6. The undersigned certifies that the trust has not been revoked, modified or amended in any manner which would cause the representations contained in this Certification to be incorrect.

7. Section 18100.5 (f) of the California Probate Code reads, in pertinent part, as follows:

(f) A person who acts in reliance upon a certification of trust without actual knowledge that the representations contained therein are incorrect is not liable to any person for so acting. A person who does not have actual knowledge that the facts contained in the certification of trust are incorrect may assume without inquiry the existence of the facts contained in the certification of trust. Actual knowledge shall not be inferred solely from the fact that a copy or part of the trust instrument is held by the person relying upon the trust certification. Any transaction, and any lien created thereby, entered into by the Trustee and a person acting in reliance upon a certification of trust shall be enforceable against the trust assets.

8. This Certification of Trust is being signed by all of the currently acting Trustees of the trust.

9. A copy or facsimile of this original Certification of Trust may be accepted and relied upon as though it was an original document.

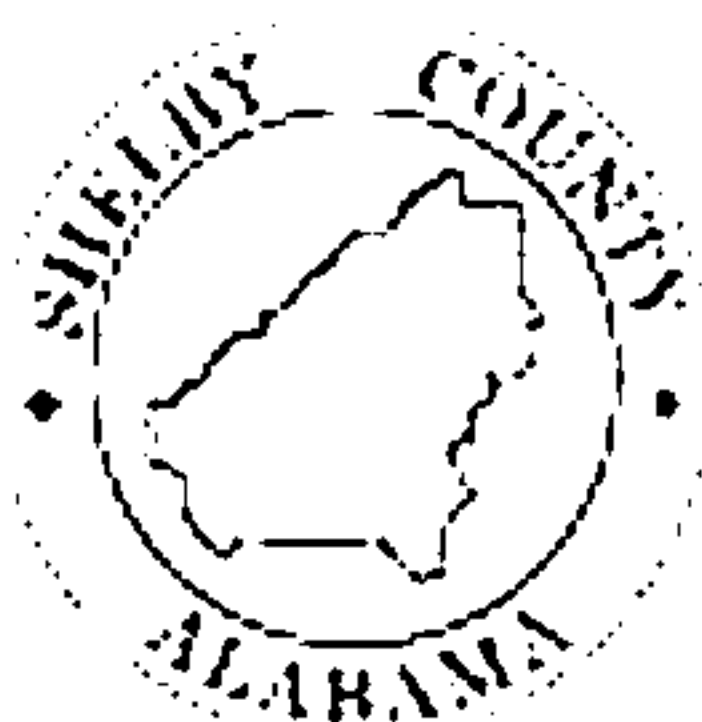
