WARRANTY DEED
JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

That in consideration of **Two Hundred Seventy Thousand and no/100 Dollars (\$270,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Melissa Hyde Carter and husband Russell Lane Carter**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Samitha Athaudha Arachchilage and Sagarika Perumadura**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 187, according to the Survey of Weatherly Warwick Village Phase I, Sector 17, as recorded in Map Book 20, Page 86, in the Office of the Judge of Probate of Shelby County, Alabama.

Melissa Hyde Carter, f/k/a Melissa D. Hyde is one and the same person as Melissa D. Coleman.


1. Ad valorem taxes for the current tax year.

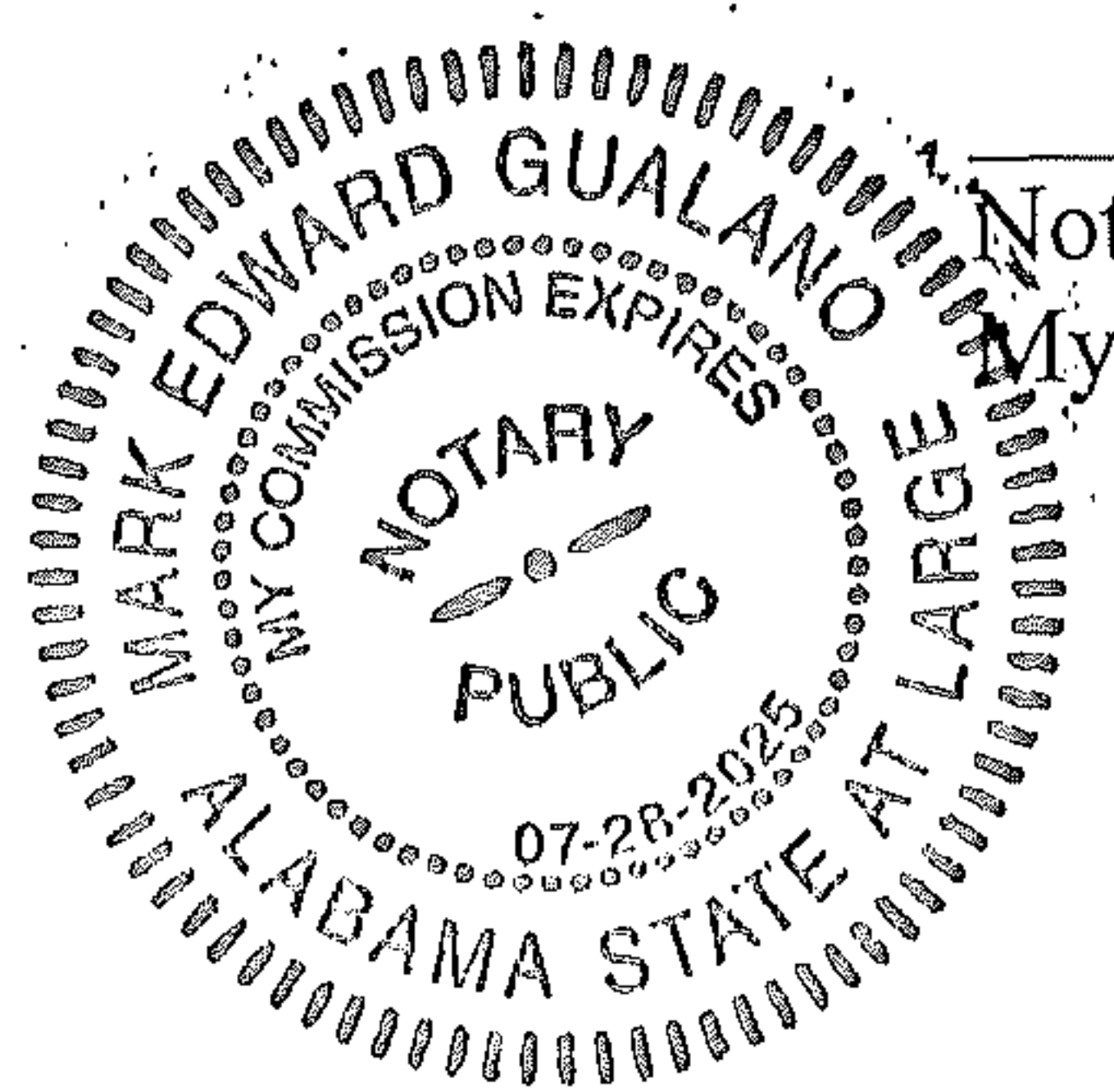
