
Certificate of Trust Bill and Pat Davis Trust



- 10. Assets held in the trust may be titled in any manner that identifies the Trustees and the name and date of the trust, for example:

William H. Davis II and Patricia Williams Davis, Trustees of the Bill and Pat Davis Trust, dated May 07, 2025.

- 11. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests of all kinds, including accounts at financial institutions.
- 12. Excerpts from the trust agreement that establish the trust, designate the Trustees, and set forth the powers of the Trustees will be provided upon request.
- 13. The trust agreement provides that a third party may rely on this Certificate of Trust in lieu of a copy of the trust agreement. It further exonerates third parties from any
