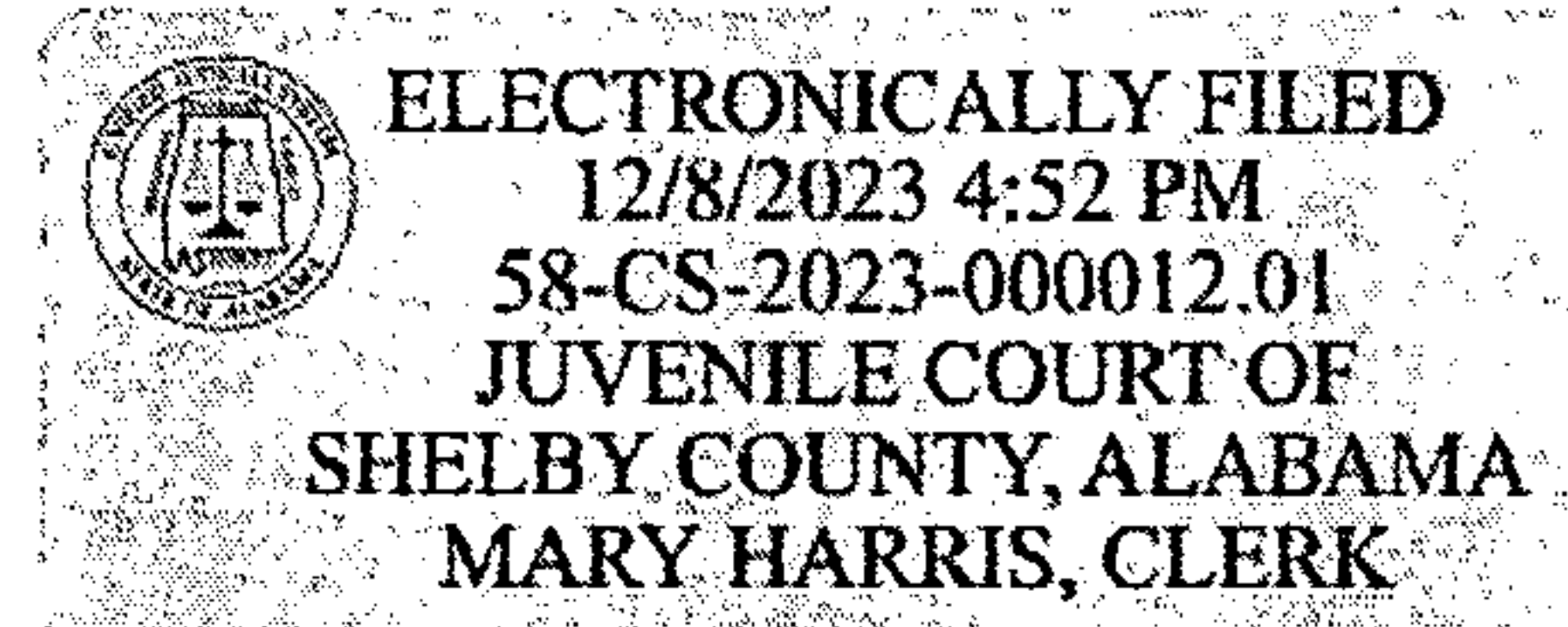

PENDENTE LITE ORDER

On the 4th day of December, 2023, this matter came before the Court for hearing on the matter of the enforcement of the order issued August 19, 2019 by the District Court of Jefferson County, Alabama requiring the payment of child support. Petitioner's interests were represented by the State of Alabama, which appeared through counsel Barry D. Woodham. Respondent personally appeared and was represented by counsel Scott Morro. Having heard the evidence and testimony,

IT IS ORDERED, ADJUDGED, and DECREED that:

1. This tribunal has subject matter jurisdiction over this proceeding;
2. This tribunal has personal jurisdiction over the parties and/or property;
3. Within this Order, the term "**Respondent**" shall refer to **Plaintiff Allen A. Poythress, Jr. (Respondent)** and the term "**Petitioner**" shall refer to **Defendant Carman Z. Currenton (Petitioner)**;
4. On or about August 19, 2019 the Respondent was ordered by the District Court of Jefferson County, Alabama to pay child support to Petitioner in specified periodic payments;
5. Respondent has failed to comply with the Order of support referenced in Paragraph 4 and is \$31,444.68 in arrears and \$5,695.30 in interest for total arrears in the amount of \$37,139.98 as of the 30th day of November, 2023, and that such failure is due to Respondent's willful neglect and not due to an inability to pay;
6. Judgment is hereby rendered in favor of the Petitioner and against the Respondent in the amount of \$31,444.68 for the support arrearage and \$5,695.30 interest for total arrears in the amount of \$37,139.98 determined as due as of 30th day of November, 2023;
7. Respondent is declared to be in contempt of court because of Respondent's willful failure to pay support as previously ordered. A separate Order of Withholding, executed contemporaneously herewith, is specifically incorporated herein as part of this Order;

8. Respondent, after being advised that he might be purged of contempt by paying the noted arrearage in full and having failed to do so, Respondent is hereby ordered to be incarcerated in the county jail for a period of **20 days**;
9. The sentence of incarceration is hereby **SUSPENDED** on the following conditions:
- A. That Respondent pay **\$667.00** per month in current child support plus an additional **\$100.00** per month toward child support arrearages totaling **\$31,444.68 plus \$5,695.30 in interest, for total arrears in the amount of \$37,139.98**;
 - B. That such sum is reduced to a judgment for which execution may issue;
 - C. That all specified payments are to begin on 1st day of January, 2024 and are to be made directly by the Respondent and are payable to **Alabama Child Support Payment Center, P.O. Box 244015, Montgomery, Alabama 36124-4015** unless and until such payments are deducted from Respondent's wages and submitted to the Alabama Child Support Payment Center pursuant to the separate Order of Withholding, which this Court directs to be served on Respondent's employer and/or the Department of Industrial Relations at this time. Payments may also be made through the State of Alabama as set forth in Exhibit A, attached hereto. Any amounts paid that are NOT made through income withholding order OR as set forth in Exhibit A shall be considered gifts to the child(ren) and shall not be credited as payment toward child support unless otherwise ordered;
 - D. That Respondent shall immediately notify the Shelby County Department of Human Resources of any change of address, change of employment, or lapse or change in any insurance coverage (if Respondent is ordered to provide such insurance coverage);
 - E. This matter is set for compliance review on 1/3/24 at 9:00 a.m. in Courtroom #1B. Defendant is **ORDERED** to be present for such review.
10. Both parents are ordered to contact Vineyard Family Services in Pelham to arrange respective participation in Motherhood and Fatherhood Initiative. 205-317-9897.

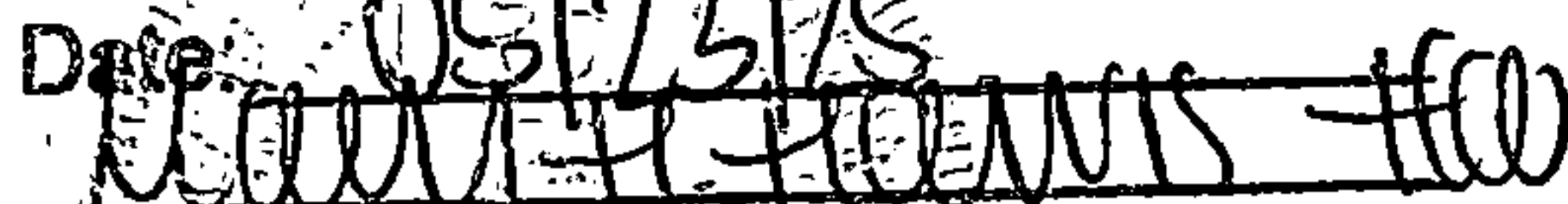

EXHIBIT A**How To Make Child Support Payments:**

1. Make payments at local DHR office, contact local office before attempting to make payments, as some offices will not accept payments.
2. Mail in payments by personal check, money order or cashier's check to: Alabama Child Support Payment Center (ACSPC), P.O. Box 244015, Montgomery, AL 36124. You will need to include your Participant ID # on all payments that you send.
3. Online through Expert Pay (www.expertpay.com). You will need to allow for 4 business days for processing of payments. Please note that there is a fee associated with using Expert Pay.
4. Make payments (with cash including a \$3.99 fee) at any MoneyGram location (CVS, Walmart, Kroger and Advance America Cash Advance). Your account number is your Participant ID number below. Please use Receive Code: 14693.
