
THEREFORE, THE ARTICLES OF INCORPORATION ARE HEREBY AMENDED AS FOLLOWS:

5. That Glenn C Siddle executes this Amendment as his acknowledgment that he is the registered agent for Melrose Landing Homeowners Association Inc.



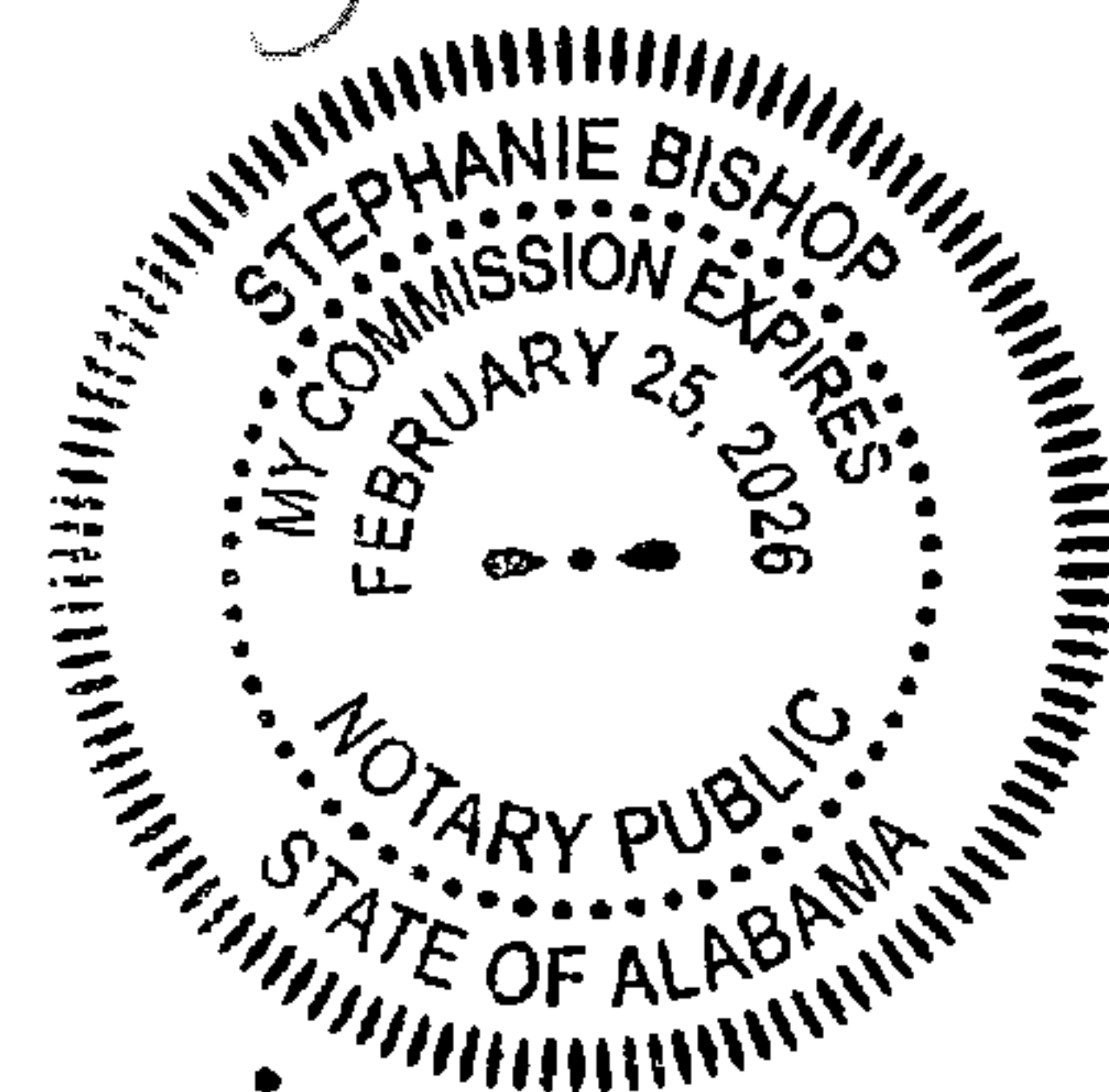
