For ad valorem tax purposes only, the address of the above-described property is 1001 Baron Lane, Chelsea, AL 35043.

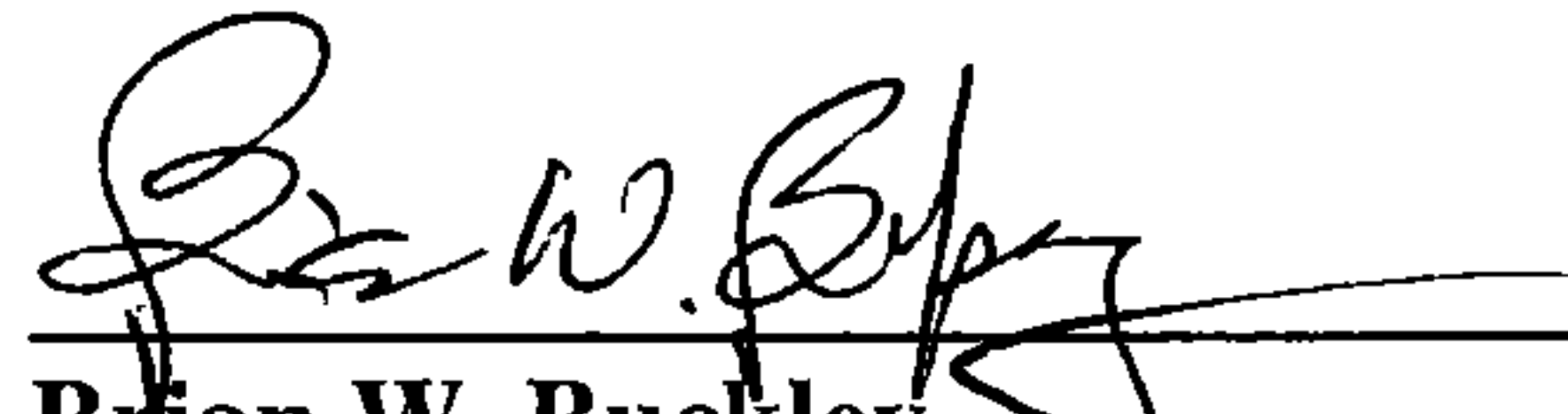

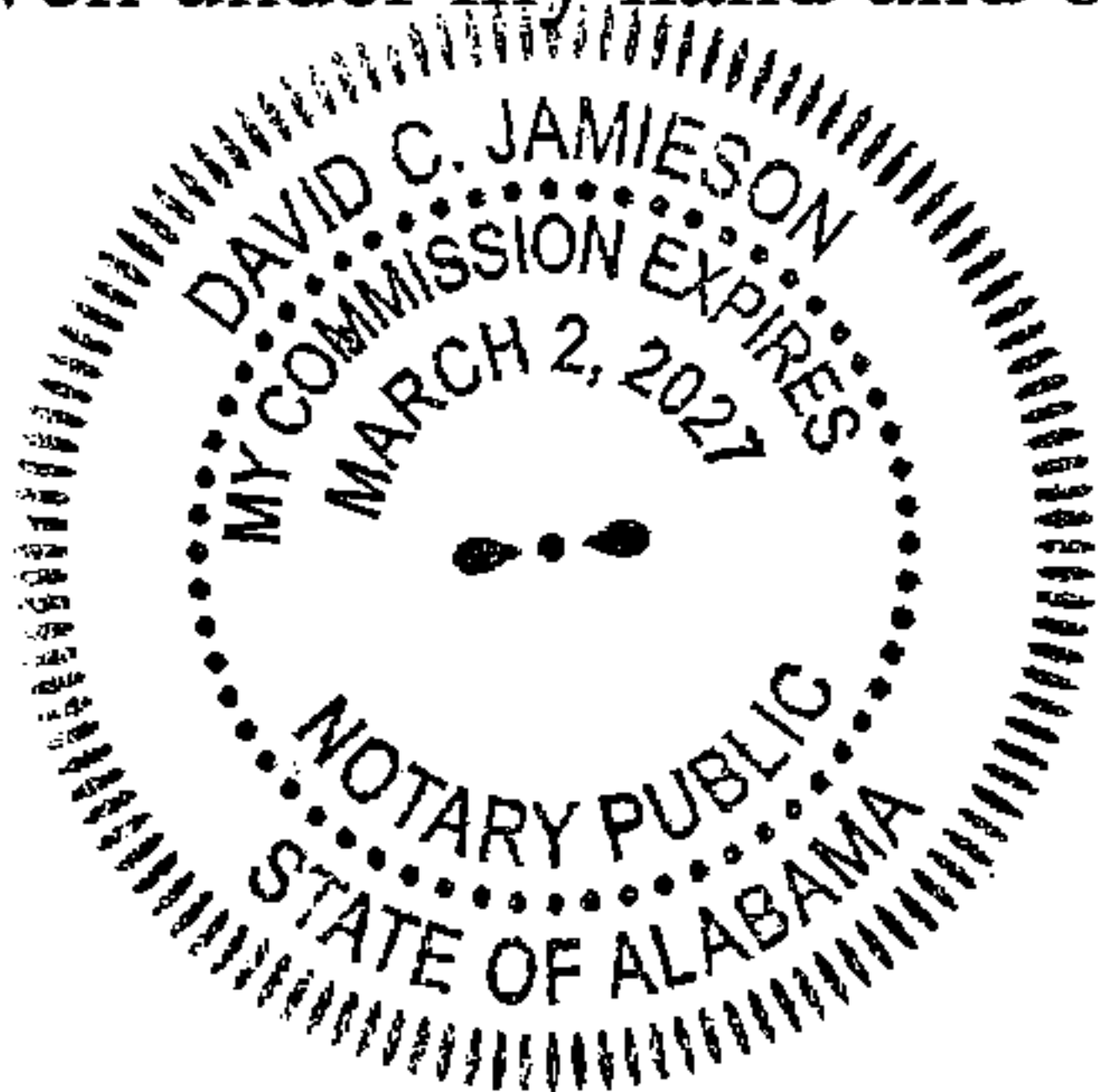


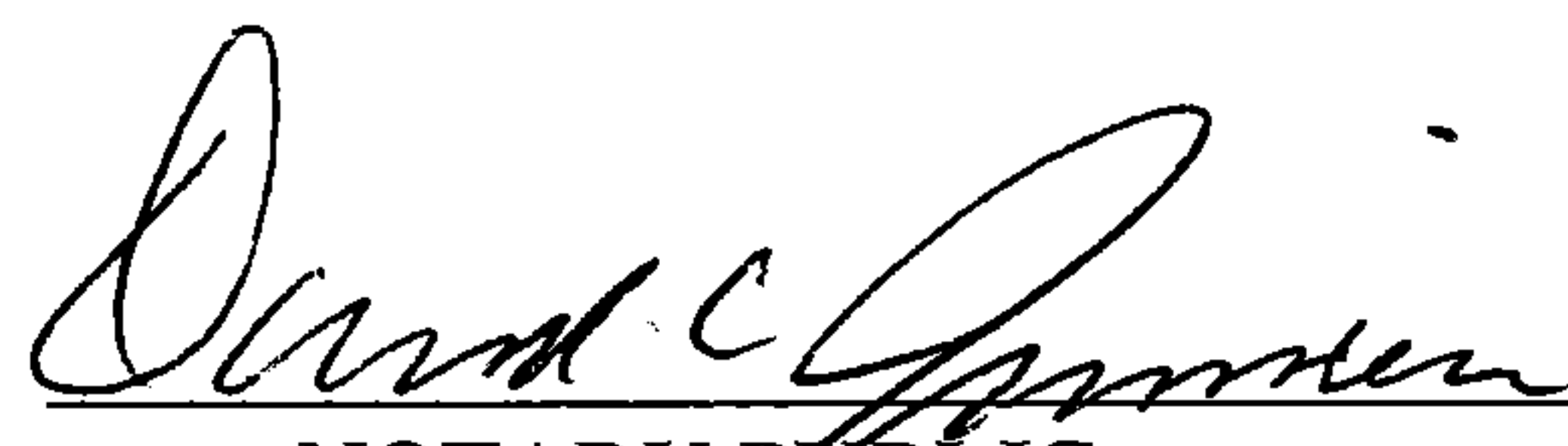
