WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of THREE HUNDRED TWO THOUSAND AND NO/100 DOLLARS (\$302,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantors, **CHARLES R. TAYLOR and SHIRLEY F. TAYLOR, husband and wife** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ANGELA M. ROBISON and SAMUEL ROBISON** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 513, according to the Survey of Lake Forest, 5th Sector, as recorded in Map Book 30, Page 25, in the Office of the Judge of Probate of Shelby County, Alabama.



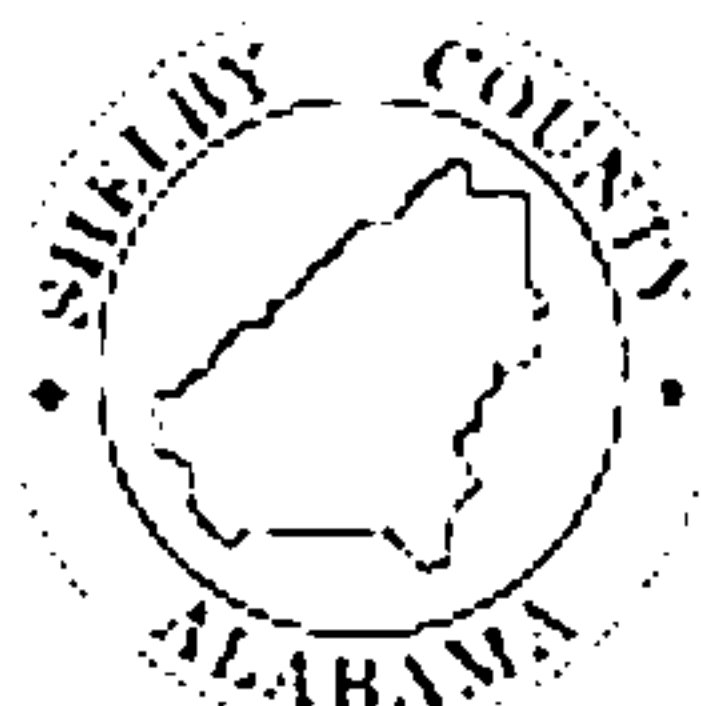
