CERTIFICATE OF TRUST

When you transact business on behalf of your Revocable Living Trust, you will sometimes be asked to produce a copy of your Revocable Living Trust document. Financial institutions and others who deal with you will want proof that your Revocable Living Trust exists, that they are dealing with the true Trustee, and that your Revocable Living Trust gives your Trustee the power to do what your Trustee proposes to do.

If your Revocable Living Trust includes personal or financial information that you want to keep private, most financial institutions will allow you to substitute a Certificate of Trust. The Certificate of Trust may include copies of key pages of your Revocable Living Trust as attachments. Normally, these pages will confirm:

- the identity of the current and successor Trustees of your Revocable Living Trust;
- the authority and powers that the Revocable Living Trust grants to the Trustees;
and
- the signatures required by the Revocable Living Trust.

Pursuant to Ala. Code § 19-3B-1013, this Certification of Trust is signed by all the currently acting Trustees of the MARLISA KOHL BANNISTER LIVING TRUST dated December 3, 2014, as restated on January 17, 2024, who declare:

1. The Grantor of the trust is MARLISA KOHL BANNISTER. AKA MARLISA K. BANNISTER AND MARLISA TERRY KOHL. The trust is revocable by the Grantor.
2. The Trustees of the trust are MARLISA KOHL BANNISTER and MARLISA KOHL BANNISTER.
3. The Trustee Succession provisions are set forth in Article Three of the trust.
4. The tax identification number of the trust is the Social Security number of MARLISA KOHL BANNISTER.
5. Title to assets held in the trust will be titled as:

MARLISA KOHL BANNISTER and MARLISA KOHL BANNISTER, Trustees,
or their successors in interest, of the MARLISA KOHL BANNISTER LIVING
TRUST dated December 3, 2014, and any amendments thereto.

6. An alternative description will be effective to title assets in the name of the trust or to designate the trust as a beneficiary if the description includes the name of at least one initial or successor Trustee, any reference indicating that property is being held in a fiduciary capacity, and the date of the trust.
7. Excerpts from the trust document that establish the trust, designate the Trustee, and set forth the powers of the Trustee will be provided upon request. The powers of the Trustees include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.
8. The terms of the trust provide that a third party may rely upon this Certification of Trust as evidence of the existence of the trust and is specifically relieved of any obligation to inquire into the terms of this trust or the authority of my Trustee, or to see to the application that my Trustee makes of funds or other property received by my Trustee.
9. The trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.

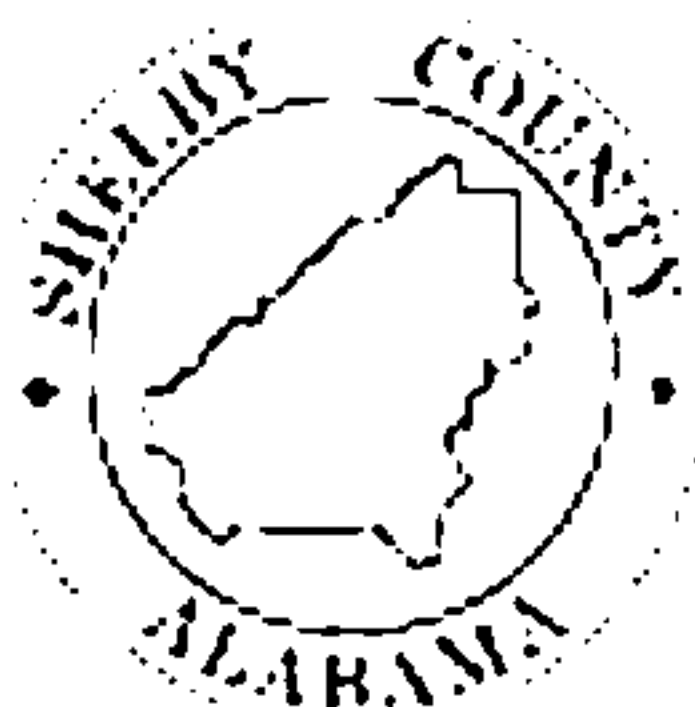
