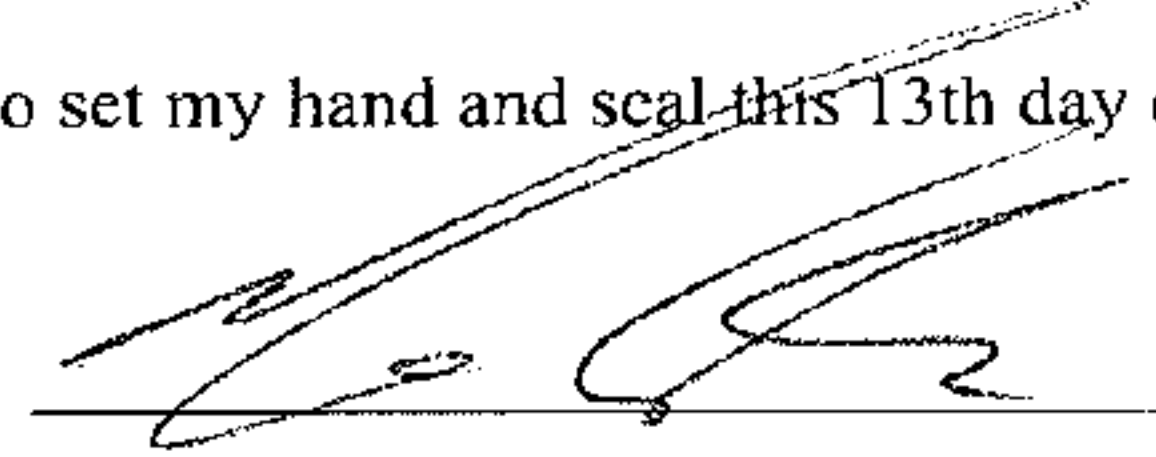
\$331,877.00 of the purchase price recited above has been paid from the proceeds of a mortgage loan closed simultaneously herewith.

Note: Hannah Catherine Carter is one and the same person as Hannah Catherine Lovejoy who acquired title in Instrument No. 20211203000578250.

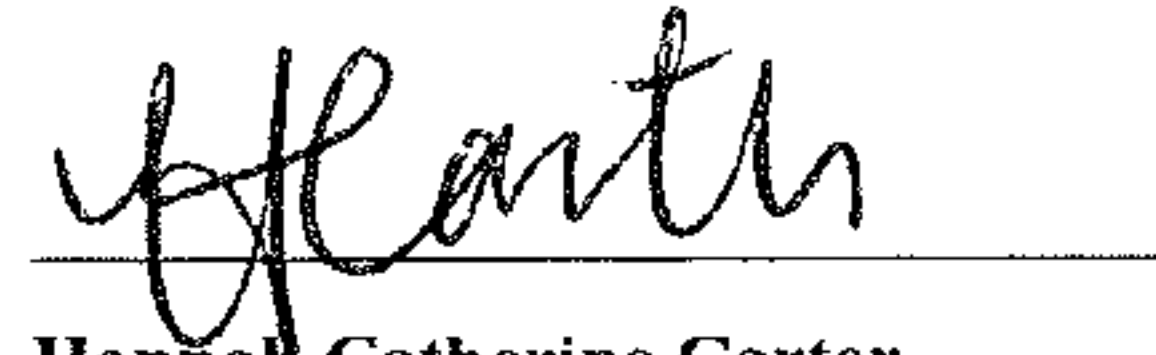

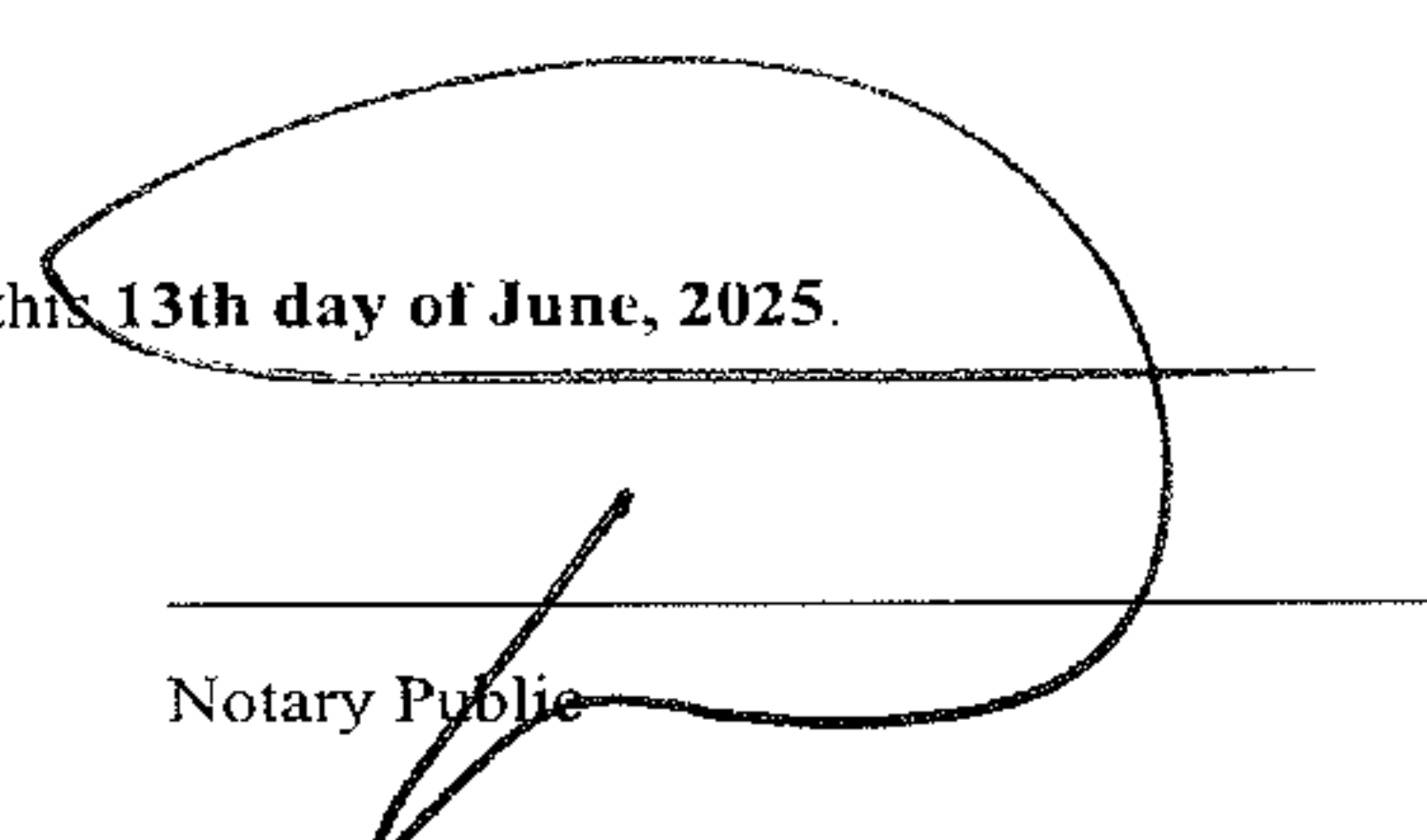

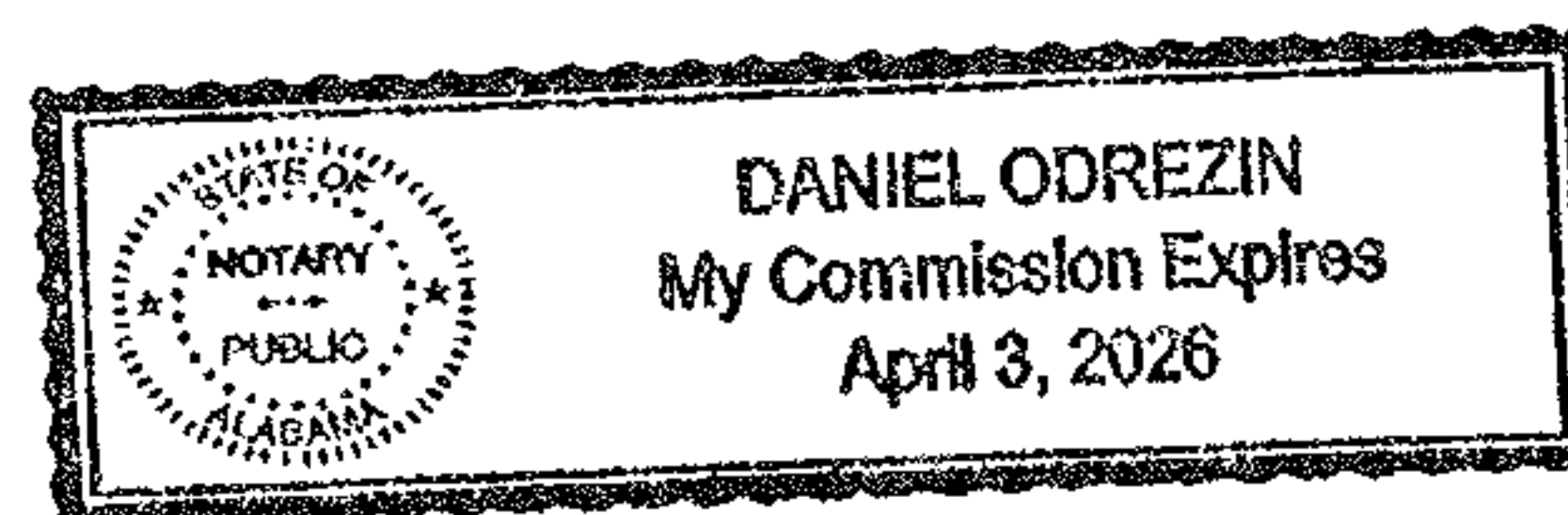
