That in consideration of Three Hundred Thirty-Four Thousand Four Hundred and 00/100 (\$334,400.00) Dollars and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto Jason Alexander Leon Cruz and Jonathan Alexis Leon Cruz (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in Shelby County, Alabama, to-wit:

Lot 82, according to the Final Plat of Koslin Farms Phase 3, as recorded as Instrument Number 20240529000159330 in Map Book 60, Page 3, in the Office of the Judge of Probate of Shelby County, Alabama.

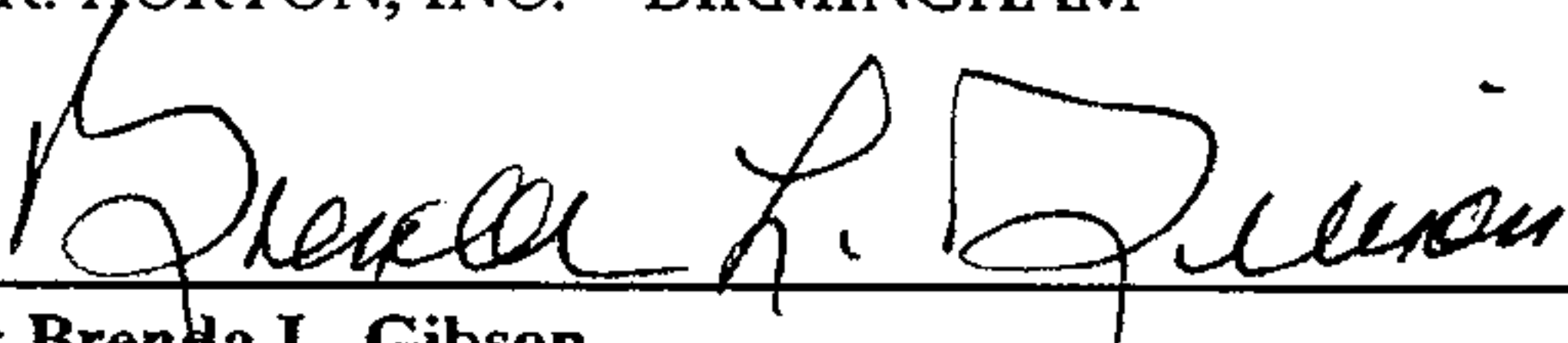
Mineral and mining rights excepted. Subject to: current taxes not yet due and payable, conditions, covenants, easements and restrictions of record.

This covenant and agreement shall run with the land conveyed hereby as against Grantees, and all persons or entities holding under or through Grantees.
