AFFIDAVIT OF HEIRSHIP

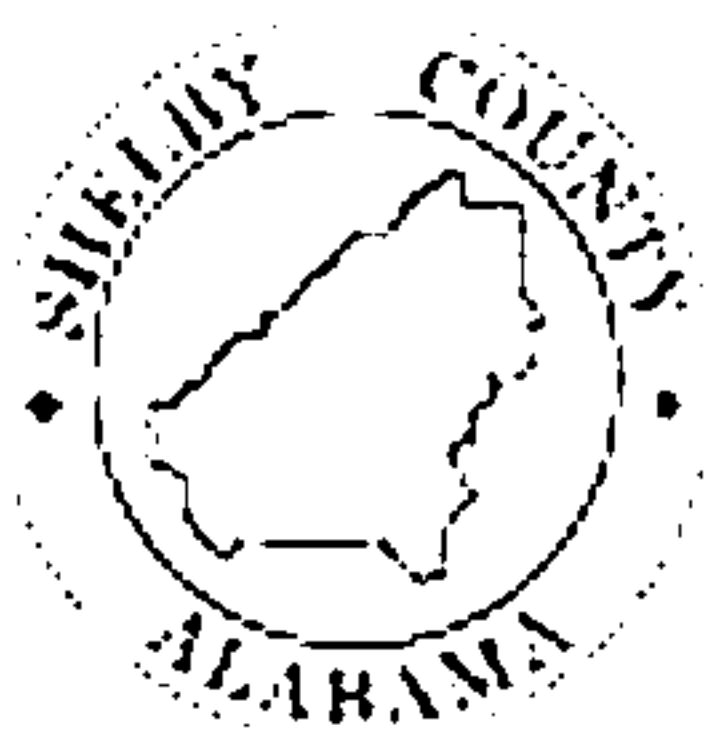
