**WARRANTY DEED
JOINT TENANTS WITH RIGHT OF SURVIVORSHIP**

That in consideration of **Four Hundred Five Thousand and no/100 Dollars (\$405,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Ashley Trammell, and husband, Joseph Trammell and Barbara Burks-Hauss, an unmarried woman**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **William Curtis Braddy and Precious Jeanine Braddy**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

\$418,365.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.


1. Ad valorem taxes for the current tax year.
