Nomination and Appointment of Personal Representative and Grant of General Authority

No bond shall be required of my Personal Representative or of any successor Personal Representative serving hereunder. I grant to my Personal Representative all general authority and power to act pursuant to the laws and Code of Alabama, and to exercise such authority legally according to said laws without the requirement of the approval or license of any court, and without the requirement of preparing or distributing any accounting or other report to any court or any other person.

Disposition of Property

I hereby give, grant, devise and bequeath all my property, real, personal and mixed, to my husband, Lee Grant Gober, Jr. If Lee Grant Gober, Jr. pre-deceases me, I give, grant, devise and bequeath all my property as above described to my children, Morgan D. Gober, Elisabeth A. Gober, and Courtney N. Gober Gardner, in equal shares, per stirpes and not per capita.

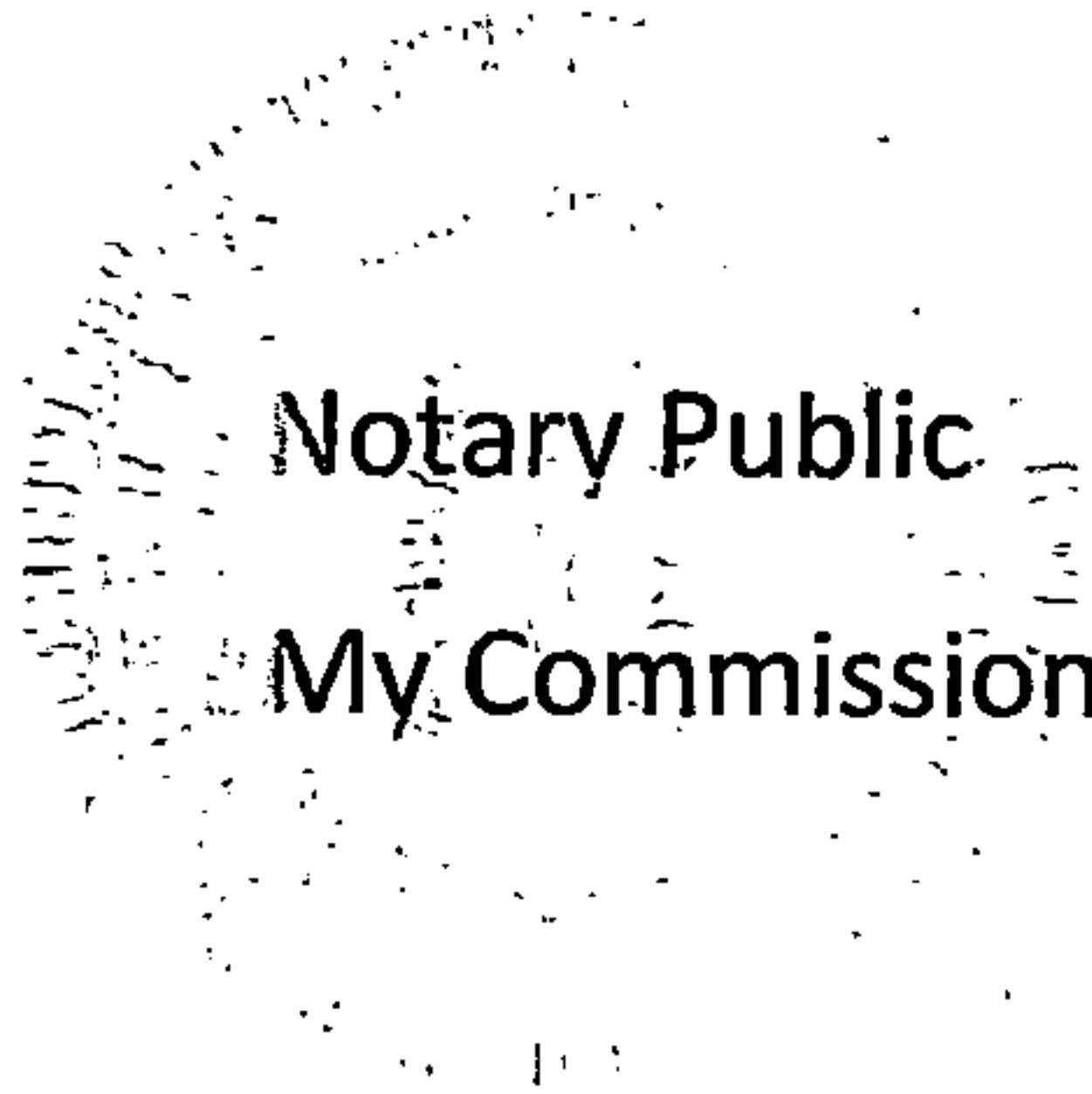
