WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP
STATE OF ALABAMA
SHELBY COUNTY **KNOW ALL MEN BY THESE PRESENTS**

That in consideration of **SIX HUNDRED TWENTY EIGHT THOUSAND AND 00/100 Dollars (\$628,000.00)** to the undersigned grantor in hand paid by the grantees herein, the receipt and sufficiency of which is acknowledged, we,

Dara Dye Ward and her husband Caleb Ward

(hereinafter referred to as “Grantor”) do grant, bargain, sell and convey unto

Tiffany Brown Ervin and Ralph Wesley Ervin, Jr.

(hereinafter referred to as “Grantees”), as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama to-wit:

Lot 1, according to the Survey of Southpointe, Second Sector, as recorded in Map Book 11, page 30, in the Probate Office of Shelby County, Alabama.

\$596,600.00 of the proceeds come from a mortgage recorded simultaneously herewith. Caleb Ward executes this deed solely in compliance with Alabama Code Section 6-10-3 and does not provide any warranty of title. The grantor herein Dara Dye Ward is one and the same as Dara Dye, grantee in the deed recorded in Instrument # 20210203000057420.

 - (2) all mineral and mining rights not owned by the Grantor; and
 - (3) all easements, rights-of-way, restrictions, covenants and encumbrances of record.

TO HAVE AND TO HOLD unto Grantees as joint tenants, with right of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance, that (unless the joint tenancy hereby created is severed or terminated during the joint lives of the grantees herein) in the event one grantees herein survives the other, the entire interest in fee simple shall pass to the surviving grantees, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

And I do for myself and for my heirs, executors, and administrators covenant with Grantees, their heirs and assigns, that I am lawfully seized in fee simple of said premises; that they are free from all encumbrances, unless otherwise noted above; that I have a good right to sell and convey the same as aforesaid; that I will and my heirs, executors and administrators shall warrant and defend the same to Grantees, their heirs and assigns forever, against the lawful claims of all persons.

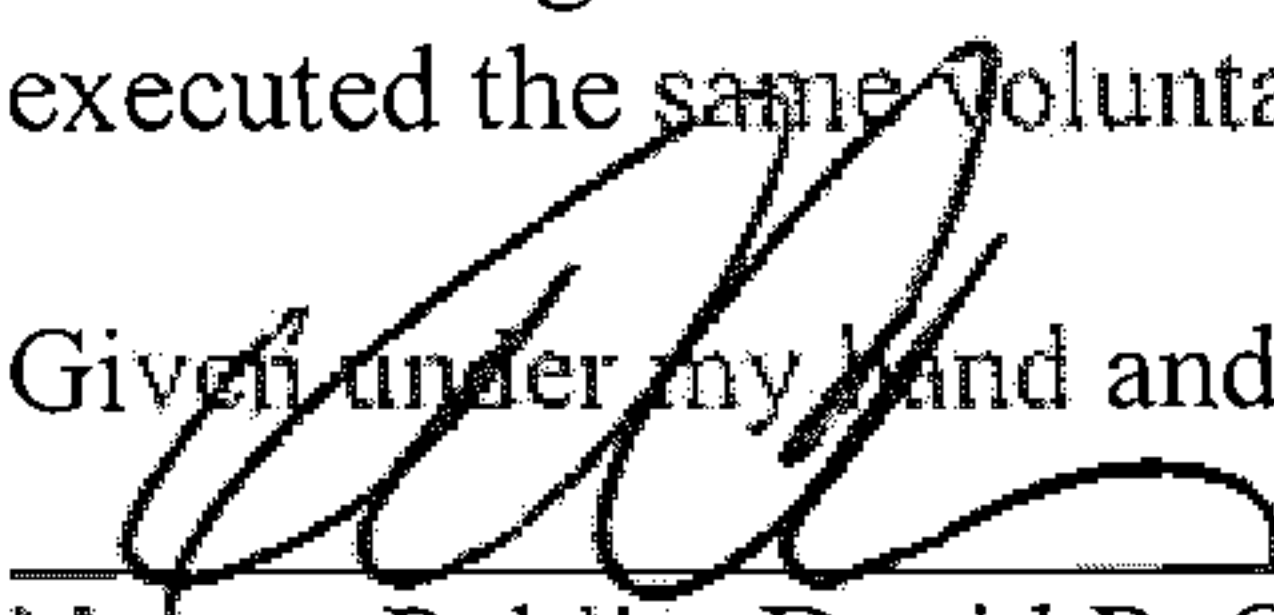

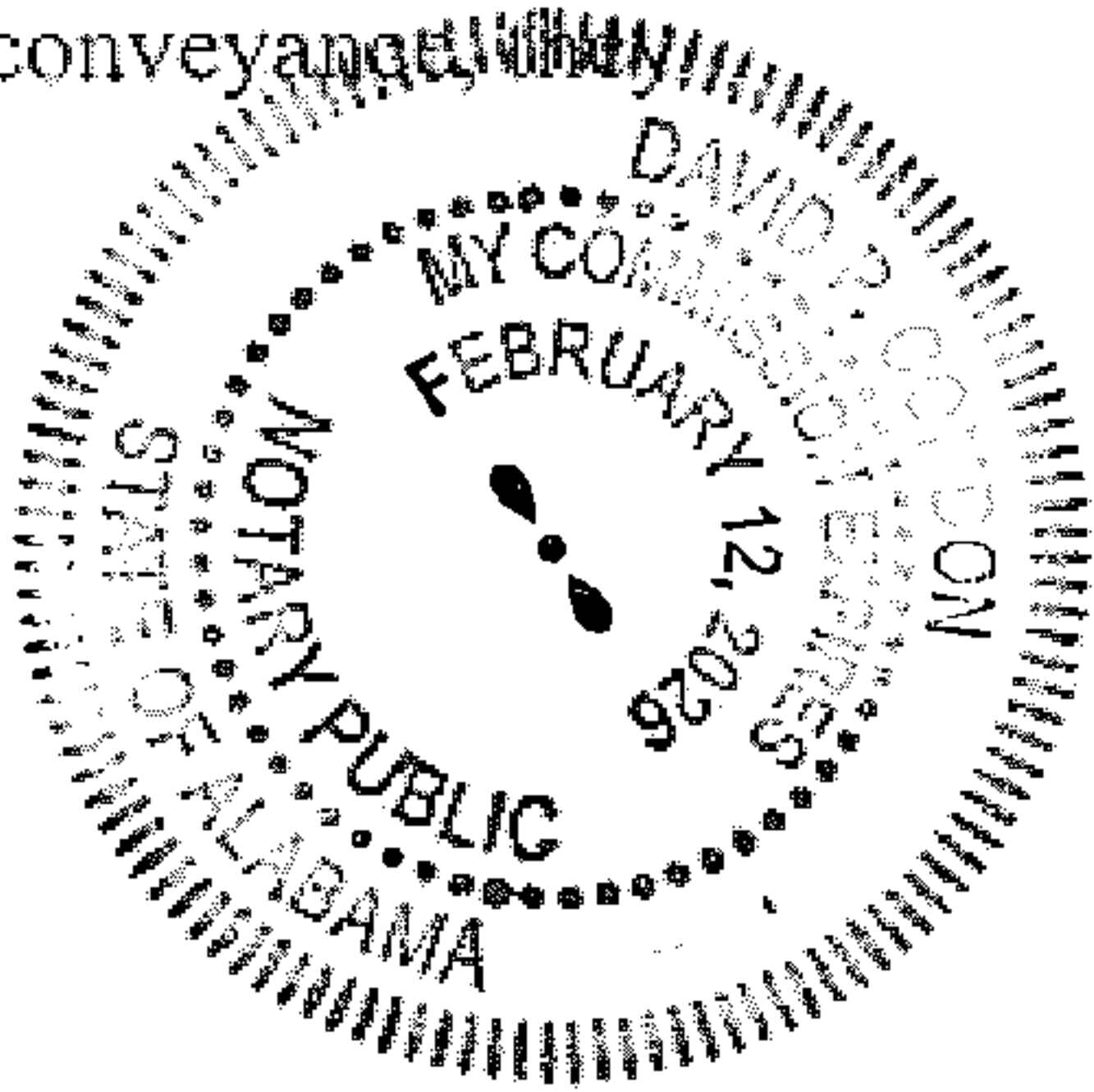
