A parcel of land located in the South ½ of Section 4, Township 22 South, Range 1 West, Shelby County, Alabama, being more particularly described as follows:

Begin at the Northwest corner of the South 1/2 of the Southeast 1/4 of said Section 4; thence North 85°28'08" Fast along the North line of said ½ - ¼ Section a distance of 393.98 fect to a point lying West and alongside of Shelby County Road No. 315 (Prescriptive Right of Way); thence South 52°46'14" East and alongside road 157.26 feet to the beginning of a curve to the left having a central angle of 28°37'10" a radius of 400.00 fect and subtended by a chord which bears South 67°04'49" East a chord distance of 197.73 feet; thence along said curve and continuing alongside of road a distance of 199.80 feet to the beginning of a reverse curve to the right having a central angle of 13°46'49", a radius of 935.70 feet and subtended by a chord which bears South 74°30'00" East a chord distance of 224.50 feet; thence along said curve and continuing alongside of said road a distance of 225.05 to the beginning of a compound curve to the right having a central angle of 60°55'03", a radius of 140.00 feet and subtended by a chord which bears South 41°58'32" East a chord distance of 141.94 fect; thence along said curve and continuing alongside of said road a distance of 148.85 feet to the end of said curve; thence south 11°31'00" East and continuing alongside of said road a distance of 13.70 feet; thence South 78°55'28" West and moving away from said road a distance of 315.00 feet; thence North 89°59'33" West a distance of 686.40 feet to a point lying on the West line of said ½ - ¼ Section; thence North 2°47'30" West along said West line a distance of 380.83 to the point of beginning.

LESS AND EXCEPT: Commence at NW corner of the S ½ of the SE ¼ of Section 4, Township 22, South, Range 1 West; thence easterly along the North line of said ½ - ¼ Section for 194.03 feet to the point of beginning; thence continue along the last described course for 200.00 feet to a #5 rebar and cap; thence turn right 42°45'38" and go 157.26 feet to a curve to the left having a central angle of 7°35'18" and a radius of 400.00 feet; thence along said curve for 52.74 feet; thence turn 107°54'02" right from the chord of said curve and go 192.14 feet; thence turn right 84°31'00" seconds and go 313.36 feet to the POINT OF BEGINNING, SITUATED IN SHELBY COUNTY, ALABAMA.
