**CERTIFICATION OF TRUST FOR REGINA VANCE LIVING

Pursuant to AL Code § 19-3B-1013

The undersigned **Alison Vance Waldrip**, being first duly sworn, deposes and says she is at least 19 years of age and is the currently acting trustee of the Regina Vance Living Trust, and further states as follows:

1. The Regina Vance Living Trust, hereinafter "The Trust", is a valid, existing trust, having been created by The Regina Vance Living Trust Agreement executed on August 5, 2024.
2. The original grantor/trustee of the trust is Regina Vance, also known as Regina Rich Vance.
3. Regina Rich Vance passed away on or about January 23, 2025.
4. In accordance with the Trustee Succession provisions of Article Three of The Trust, Alison Vance Waldrip is now the acting trustee of The Trust.
5. Excerpts from The Trust document that establish the trust, designate the trustee and successor trustee, and set forth the powers of the Trustee can be provided upon request. The powers of the Trustee include the power to acquire, sell, assign, convey, pledge, encumber, lease, borrow, manage, and deal with real and personal property interests.
6. Article Seven of The Trust provides for distribution to named beneficiaries in the event of the death of the original grantor. The names beneficiaries and their respective share of the property of The Trust are as follows:

7. The terms of The Trust provide that a third party may rely upon this Certification of Trust as evidence of the existence of The Trust and is specifically relieved of any obligation to inquire into the terms of The Trust or the authority of the Trustee, or to see to the application that the Trustee makes of funds or other property received by the Trustee.

8. All persons relying on this document regarding the Trustee and the Trustee's powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A copy of this Certificate of Trust shall be just as valid as the original.
9. The Trust has not been revoked, modified, or amended in any way that would cause the representations in this Certification of Trust to be incorrect.
