That in consideration of the sum of **Twenty Two Thousand Five Hundred Dollars and No Cents (\$22,500.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Andrew Ford**, a single man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Marlie B Wilkins and Brandon T Wilkins**, as joint tenants with right of survivorship (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 4, according to a Re-subdivision of Ford Acres, as recorded in Map Book 57, Page 82, in the Probate Office, Shelby County, Alabama.


