KNOW ALL MEN BY THESE PRESENTS,

On this June 27, 2025, That for and in consideration of **FOUR HUNDRED NINETY THOUSAND AND NO/100 (\$490,000.00) DOLLARS,** and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **DEBORAH FREEMAN, a married person,** (herein referred to as "Grantor"), in hand paid by the Grantee herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the GRANTEE, **PATRICIA A. PLUNK,** (herein referred to as "Grantee"), Grantee's heirs and assigns, any and all of the respective Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA,** to wit:

Land in Shelby County, Alabama, being Lot No. 2, Survey of Phase One, Caldwell Crossings, 2nd Sector, of record in Map Book 30, Page 116, Probate Office for Shelby County, Alabama, to which reference is hereby made for a more complete and accurate legal description of said property.

Subject to:

1. General and special taxes or assessments for the year 2025 and subsequent years not yet due and payable.
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.

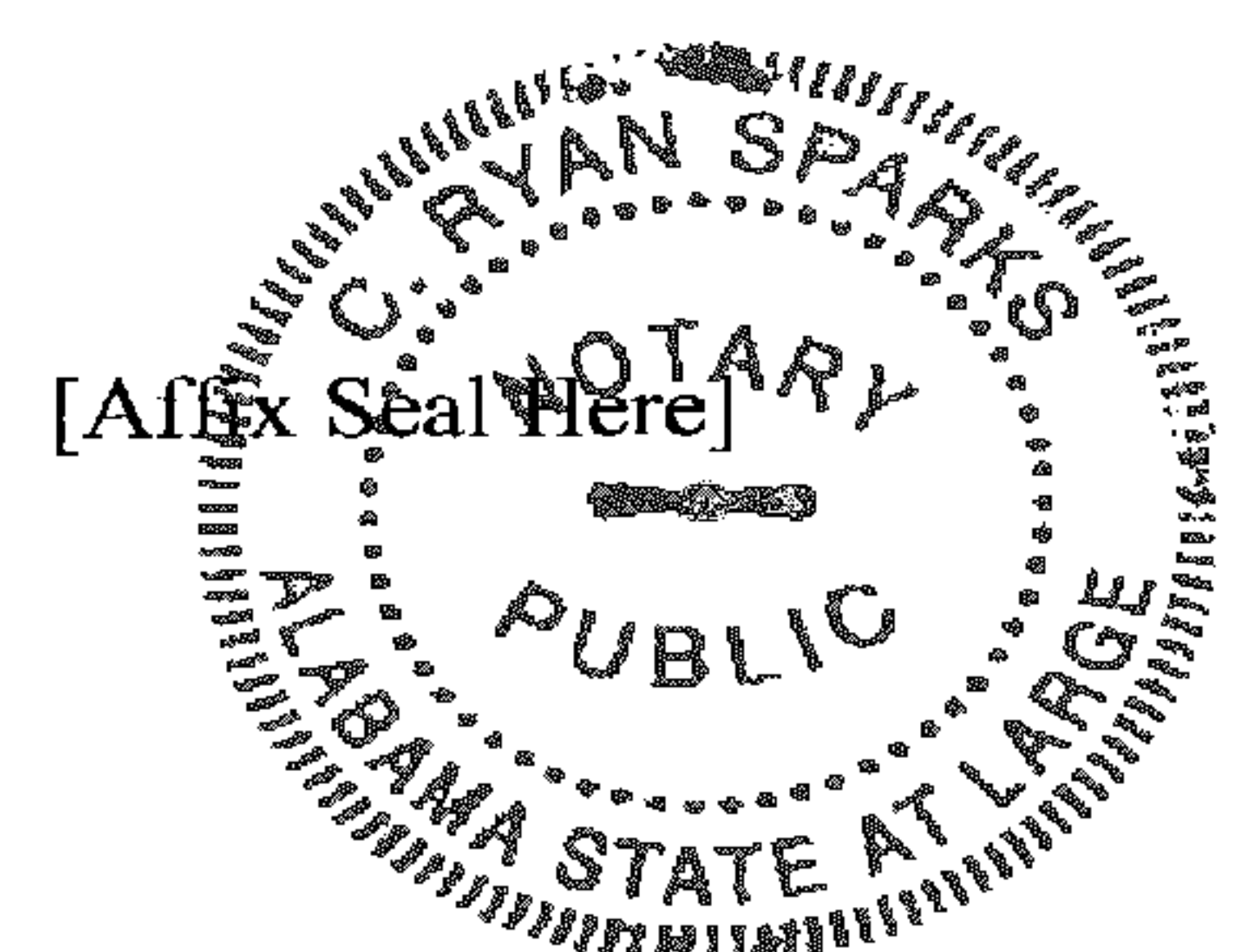
