(herein referred to as grantees), the following described real estate, situated in **Shelby** County, Alabama, to-wit:



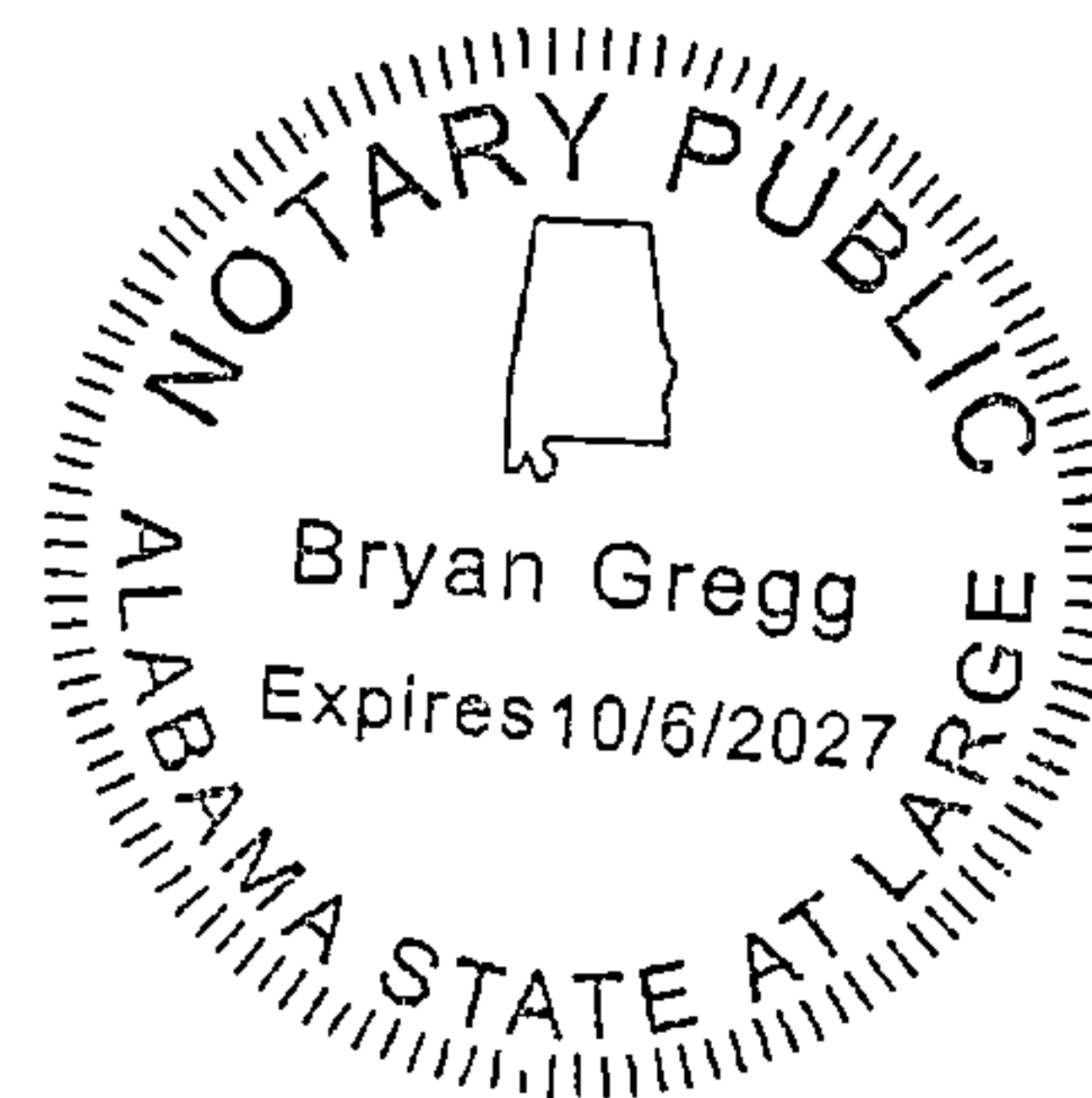
