WARRANTY DEED
JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS:

That in consideration of **Five Hundred Forty-Two Thousand, Five Hundred and no/100 Dollars (\$542,500.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **William H. Perry, Jr., and wife, Melanie P. Perry**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Anthony Julias Williams and Latrisa R. Williams**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 16, according to the Survey of Southpointe Eighth Sector, as recorded in Map Book 15, Page 109, in the Probate Office of Shelby County, Alabama.

\$542,500.00 of the purchase price recited herein was paid from the proceeds of a purchase money mortgage closed simultaneously herewith.

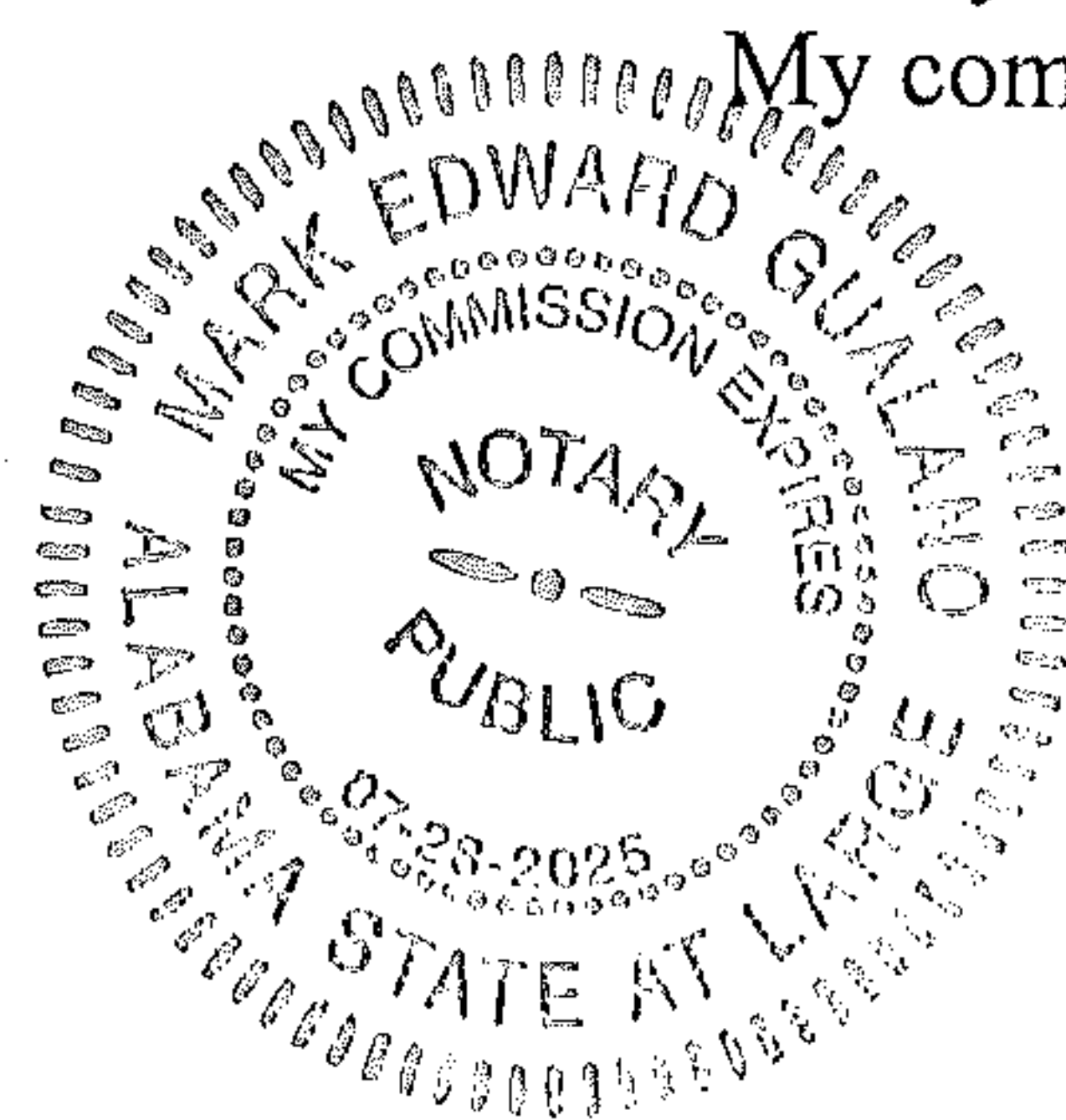
