KNOW ALL MEN BY THESE PRESENTS: That, for and in consideration of EIGHT HUNDRED FIFTY-SEVEN THOUSAND AND NO/100 DOLLARS (\$857,000.00) and other good and valuable consideration, this day in hand paid to the undersigned Grantor, **JOSEPH DUSTIN DABNEY a married man** (hereinafter referred to as Grantor), the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **NORMAN WALKER and DEBRA WALKER** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 1A, being a Resurvey of Lots 1 and 2 according to the Survey of Smith's Addition to Bridgewater Drive, as recorded in Map Book 57, Page 83A and 83B, in the Probate Office of Shelby County, Alabama.



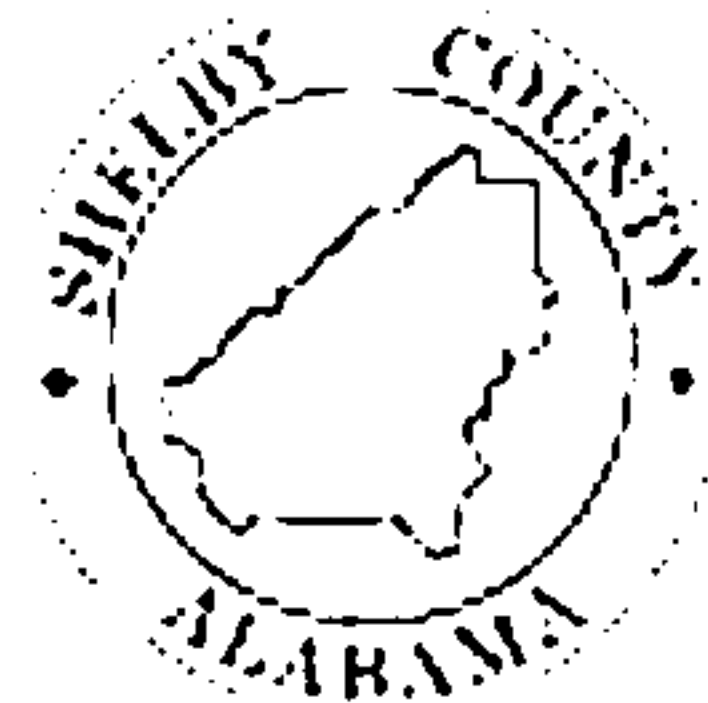
