	On 07/11/2025, Mr. Patterson came to the Shelby County Sheriff's Office to make a report of possible Identity theft.
	Mr. Patterson stated that around 10:00 am on 07/11/2025, He received a phone call from an Attorney by the name of Clay Maddox (205) 389-3920, asking him if he was selling property at Lay Lake. Mr. Patterson stated that he is not selling his and his wife's property. Mr. Maddox then stated that a man using his Alabama Driver's License is attempting to sell his property. Mr. Maddox then gave Mr. Patterson the name of the Real Estate Agents and her phone number.
	Mr. Patterson stated he then contacted Ms. Darlene Rice (205)389-3920 and asked her for the details of the possible transaction of his property. Mr. Patterson also advised Ms. Rice that he and his wife are not selling the property. Ms. Rice advised that she had received correspondence from a male using his name wanting to sell the property at 565 Mulberry Landing in Shelby Alabama. Ms. Rice then stated that as the sell was about to close, she got nervous and asked the person she was corresponding with that she needed a copy of his Driver's License. Ms. rice then stated that when she received a copy of the Driver's License, she even became more cautious and then asked Mr. Maddox to find Mr. Patterson and ask him if he is selling his property. Ms. Rice stated to Mr. Patterson that she never meet the person she was corresponding but the number she was communicating with is 945-215-2484. When Ms. Rice found out that Mr. Patterson was not selling his property, she then stopped the land deal from going any further. Ms. Rice stated that no Money was ever exchanged in the events leading up to her finding out it was a possible scam.
