The Grantor desires for the Trustee to accept and hold, pursuant to the terms of the trust, the Grantor's residence and other real and personal property.

Revocable: The Grantor reserved the right to revoke or amend this agreement by a writing (other than his will) and delivered to the Trustee(s) during Grantor's lifetime. If this agreement has been revoked but at Grantor's death an insurance policy is payable to Grantor's Trustees, the Trustees shall distribute the net proceeds of the policy to Grantor's estate.

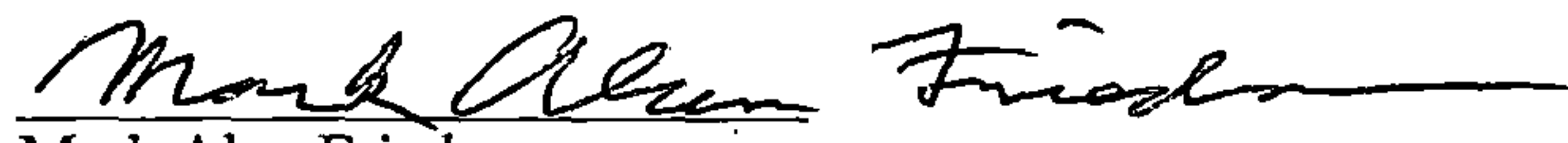
Any property of the trust shall be titled to the "IRUSSH Revocable Trust"
