A purchase money and construction mortgage filed simultaneously herewith in the amount of \$465,600.00

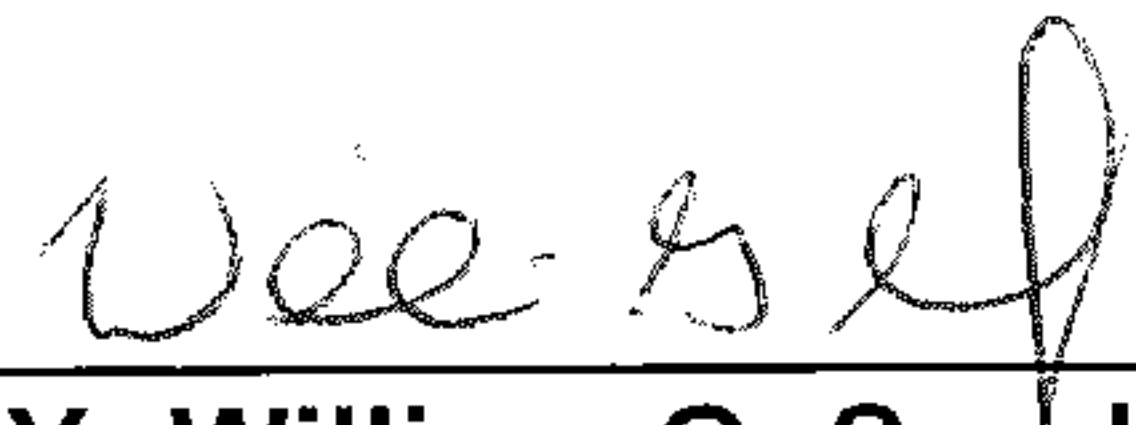
Subject to mineral and mining rights if not owned by Grantor. Subject to existing easements, restrictions, set-back lines, rights of way, limitations, if any of record.

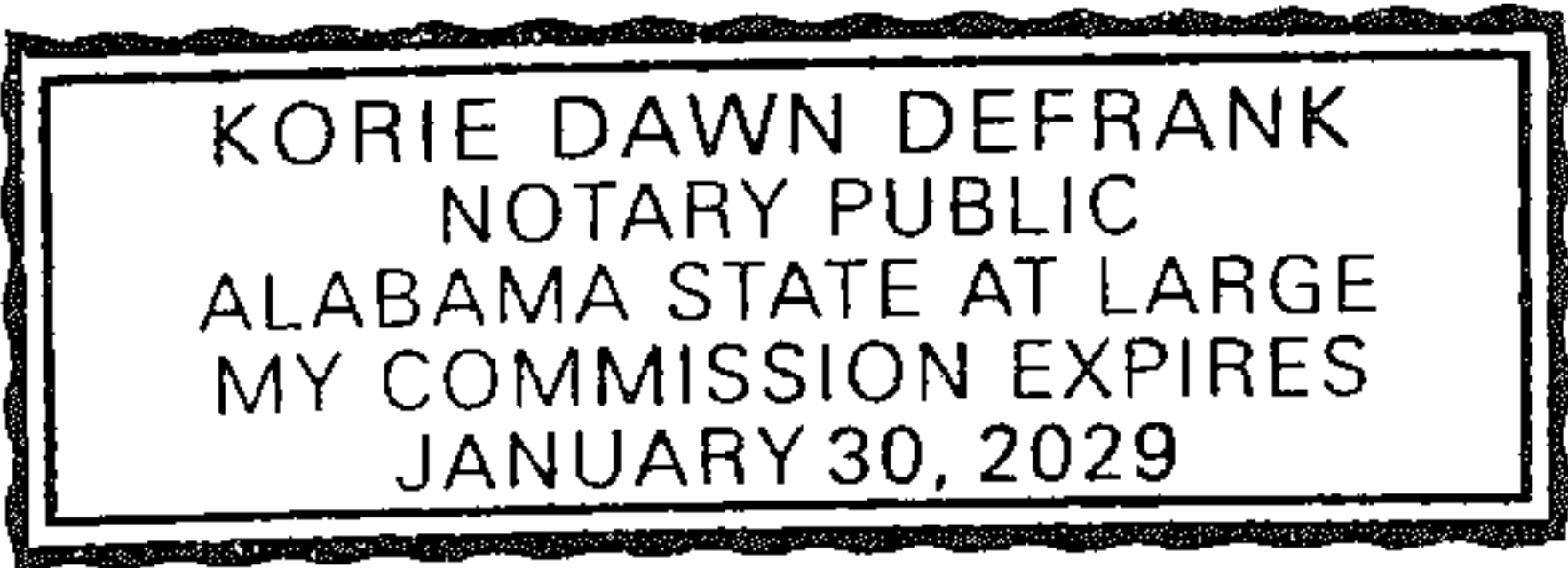

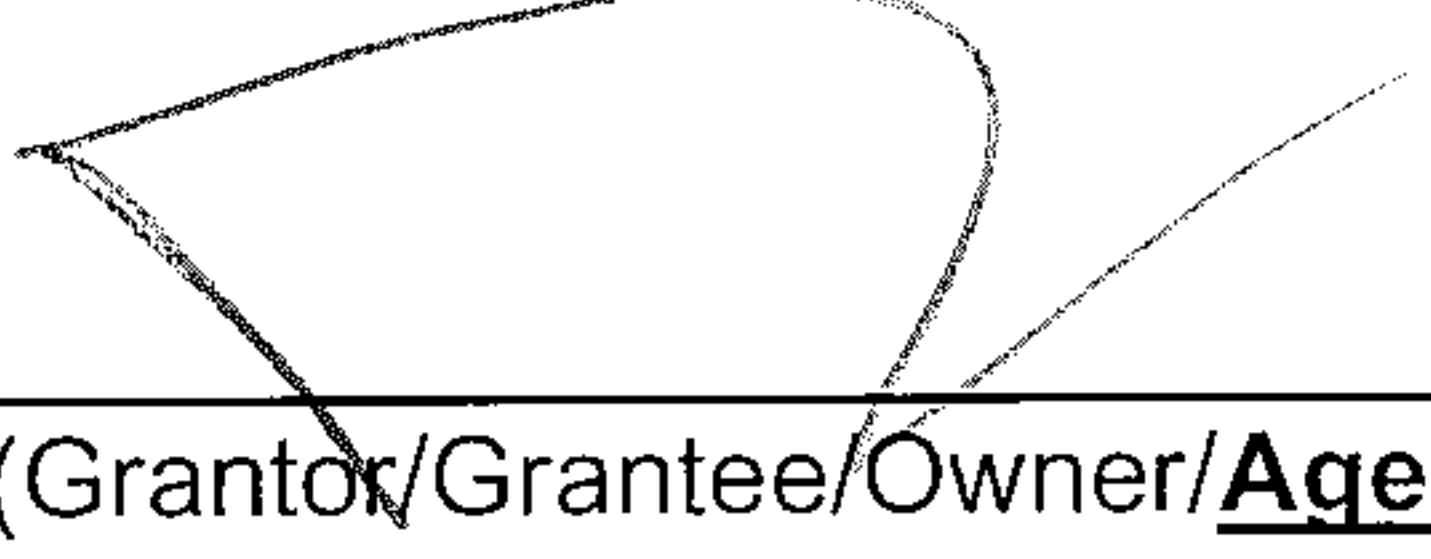
