For ad valorem tax purposes only, the address of the above-described property is 4905 Stone Creek Way, Calera, AL 35040.

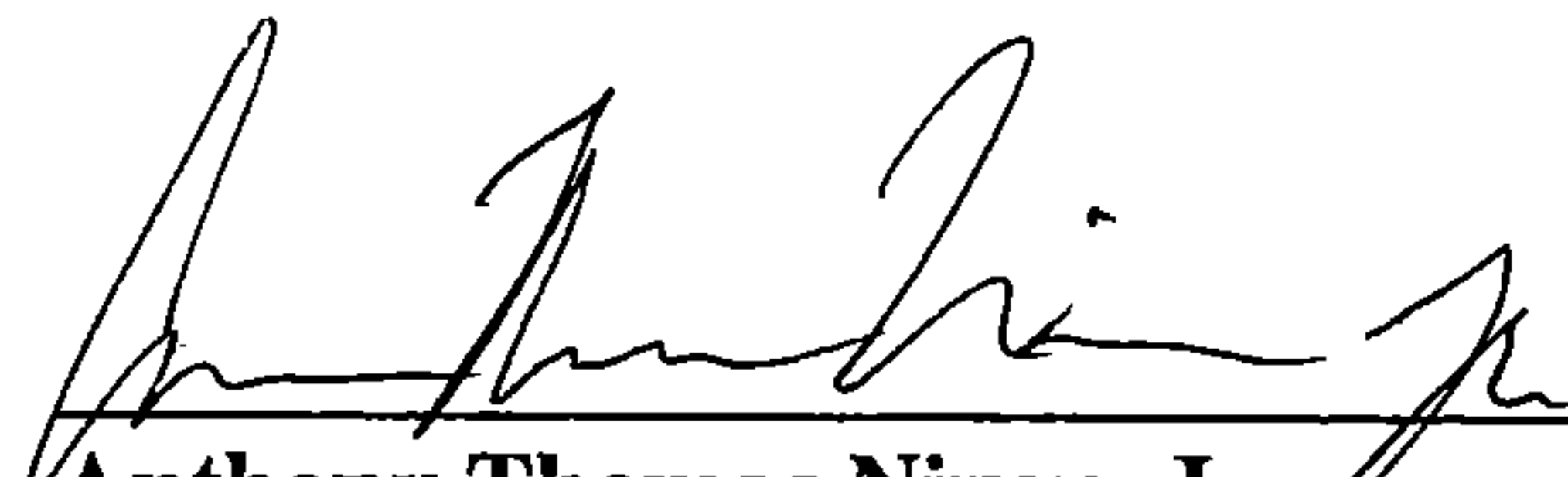
