That in consideration of **Two Hundred Ninety-Nine Thousand Four Hundred and 00/100 (\$299,400.00) Dollars** and other good and valuable consideration paid in hand by the GRANTEES herein to the undersigned GRANTOR, the receipt and sufficiency whereof is acknowledged,

D.R. Horton, Inc. – Birmingham (herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Carlos Irby (herein referred to as GRANTEE, whether one or more), all of its right, title and interest in and to that certain real estate situated in **Shelby County, Alabama**, to-wit:

Lot 97, according to the Final Plat of Koslin Farms Phase 3, as recorded as Instrument Number 20240529000159330 in Map Book 60, Page 3, in the Office of the Judge of Probate of Shelby County, Alabama.

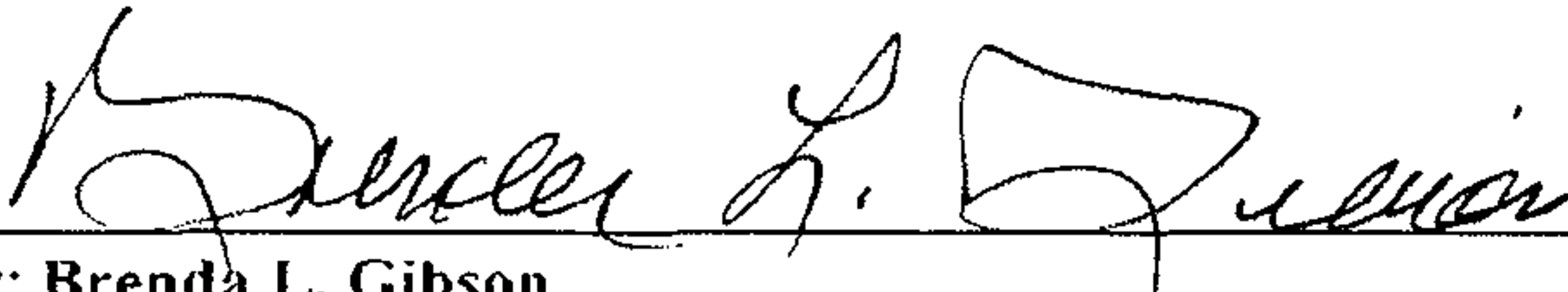

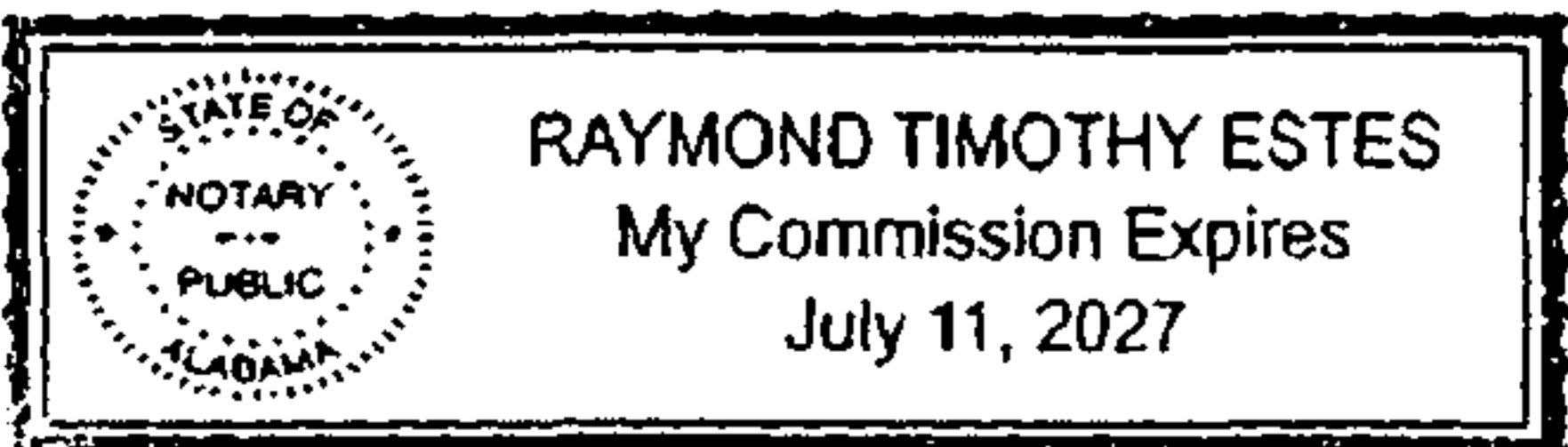
