That in consideration of **Four Hundred Fifteen Thousand and no/100 Dollars (\$415,000.00)** to the undersigned grantor(s) (whether one or more); in hand paid by the grantee(s) herein, the receipt and sufficiency of which is hereby acknowledged, I or we, **Kaitlin Erin Lebeau and Adrienne Lauren Lebeau a married couple**, (herein referred to as grantor(s), whether one or more), grant, bargain, sell and convey to **Kevin M. Bryant and Francesca M. Bryant**, hereinafter referred to as grantee(s), whether one or more), the following described real estate situated in Shelby County, Alabama to-wit:

Lot 25, in Block 1, according to the Map and Survey of Gross's Addition to Altadena South, 2nd Phase of 1st Sector, as recorded in Map Book 6, Page 17, in the Probate Office of Shelby County, Alabama.

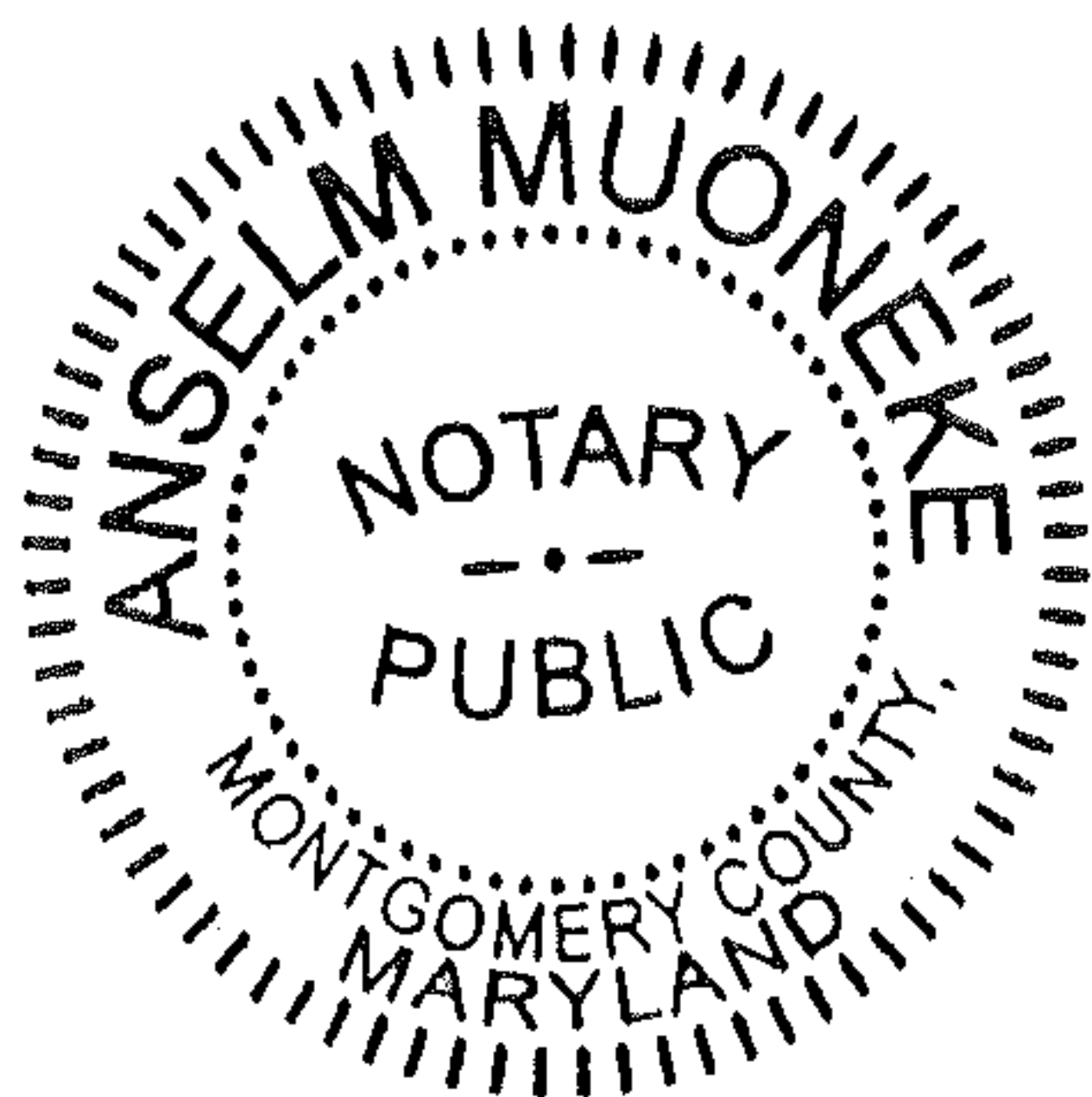
