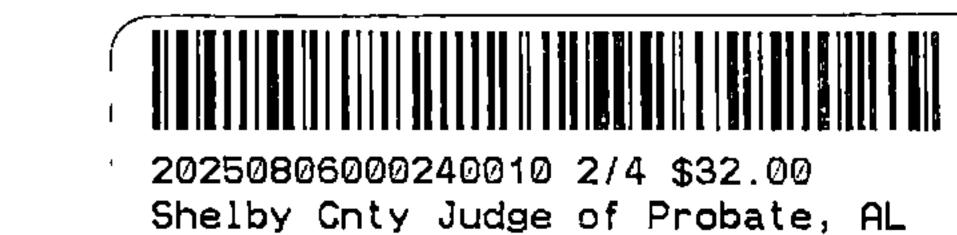
WHEREAS, no Claims have been filed in the Estate of Connie Sue Bentley, deceased, and
