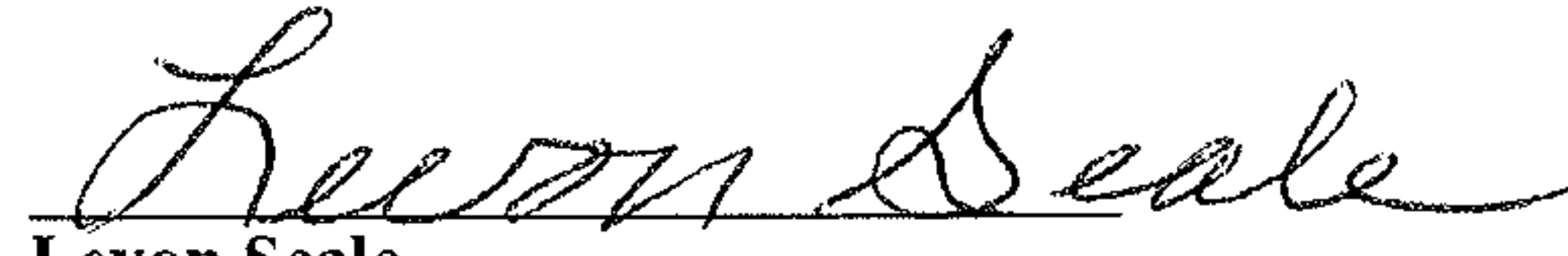
SUBJECT TO ALL MATTERS OF RECORD

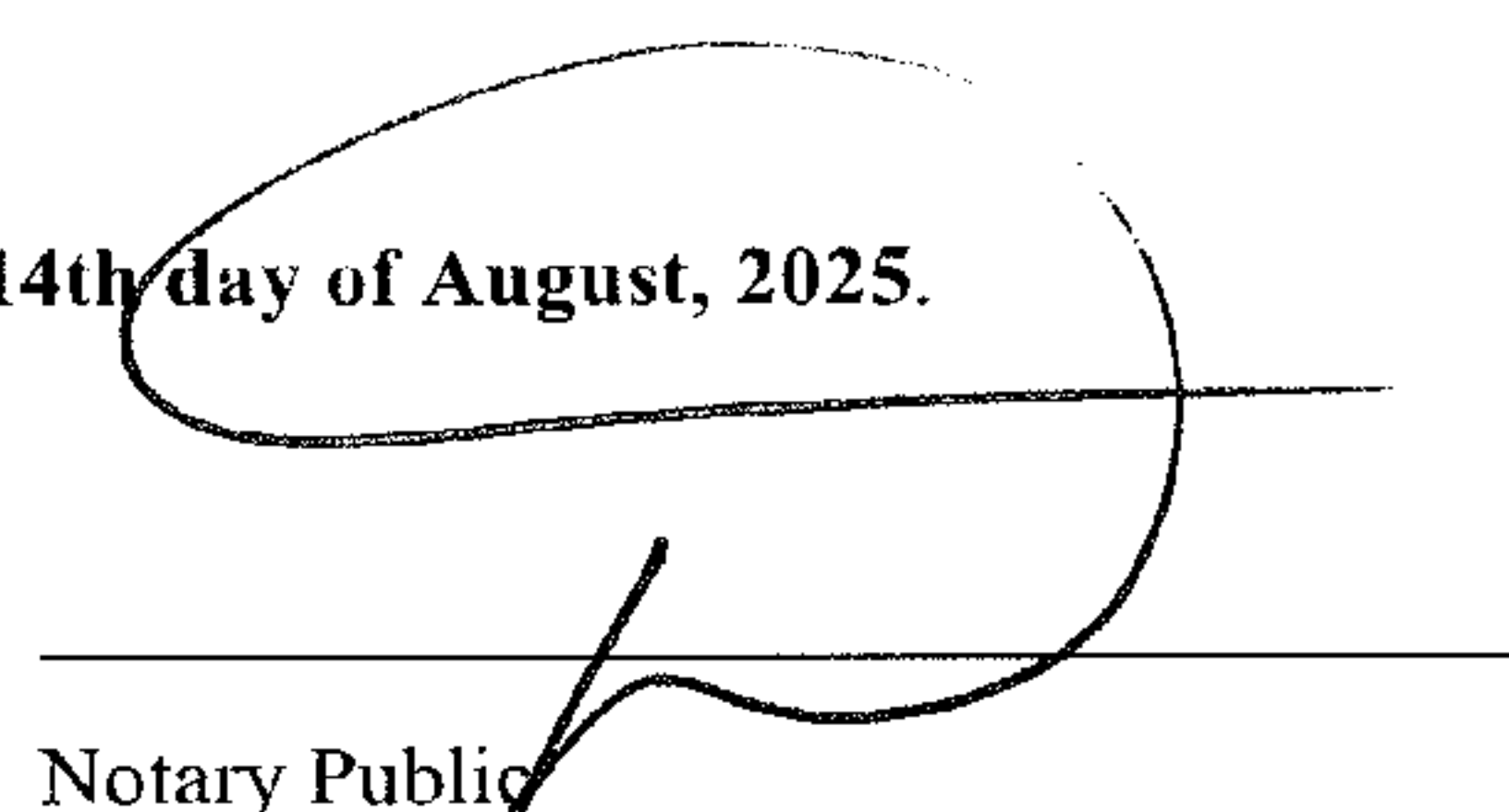

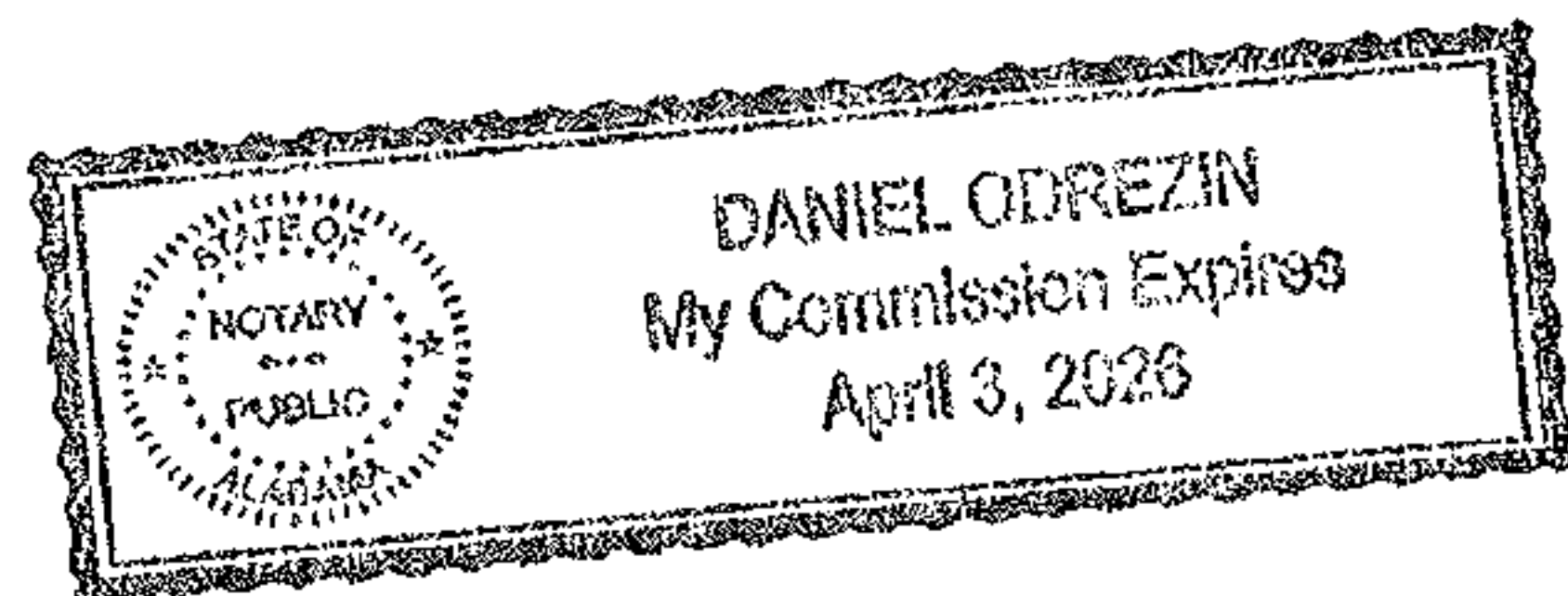
