

SPECIFIC POWER OF ATTORNEY

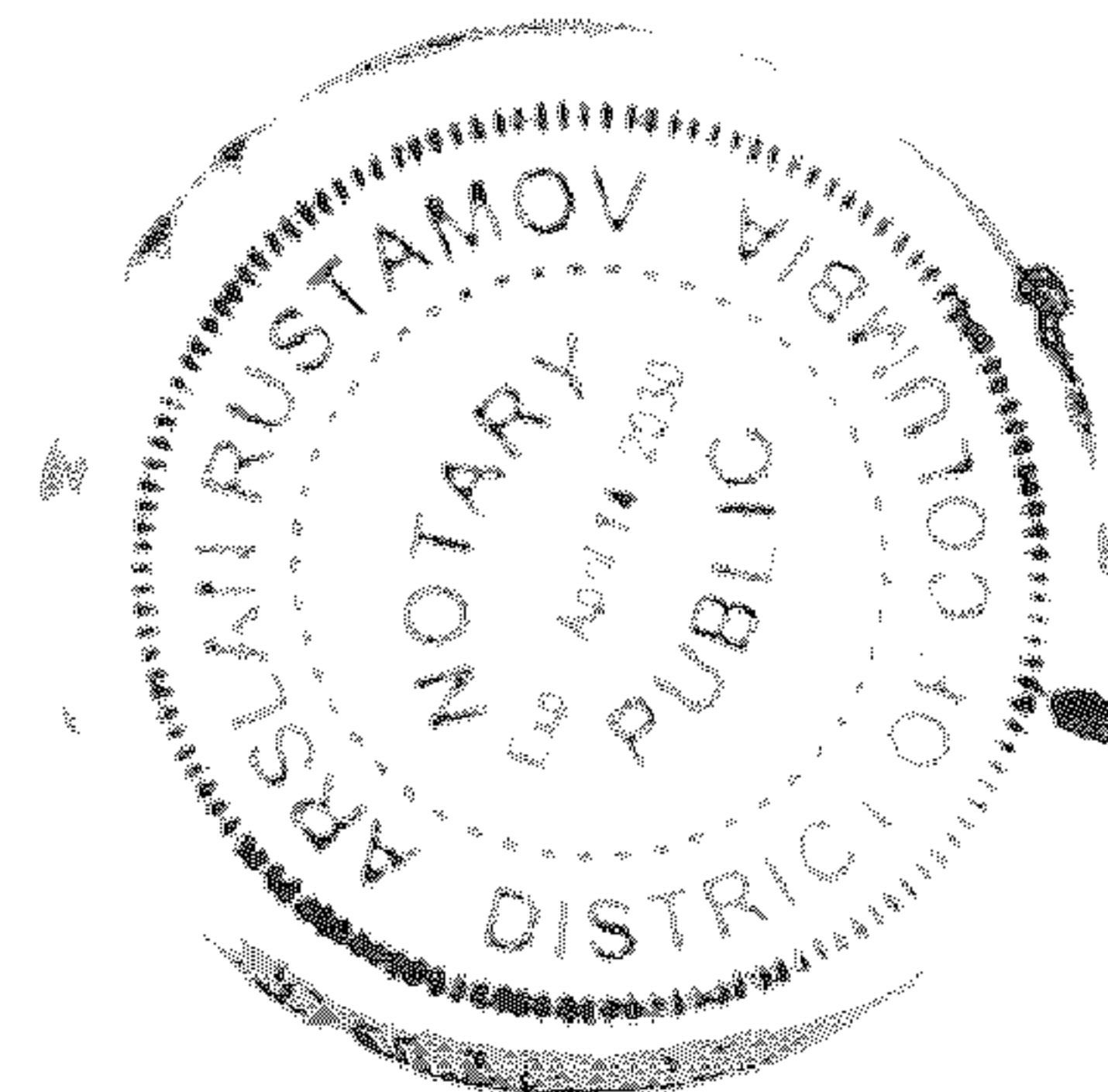
