That there are no visible encroachments upon the subject lot except as shown hereon excluding utility service lines, wires or pipes that serve the subject lot within dedicated easements or rights of way; I further certify that I have consulted the Federal Insurance Administration's Flood Hazard Map #01117C0440D for the area and have determined that the subject Lot is not in a special flood prone area.

The above described parcel contains 50,923 square feet.
