

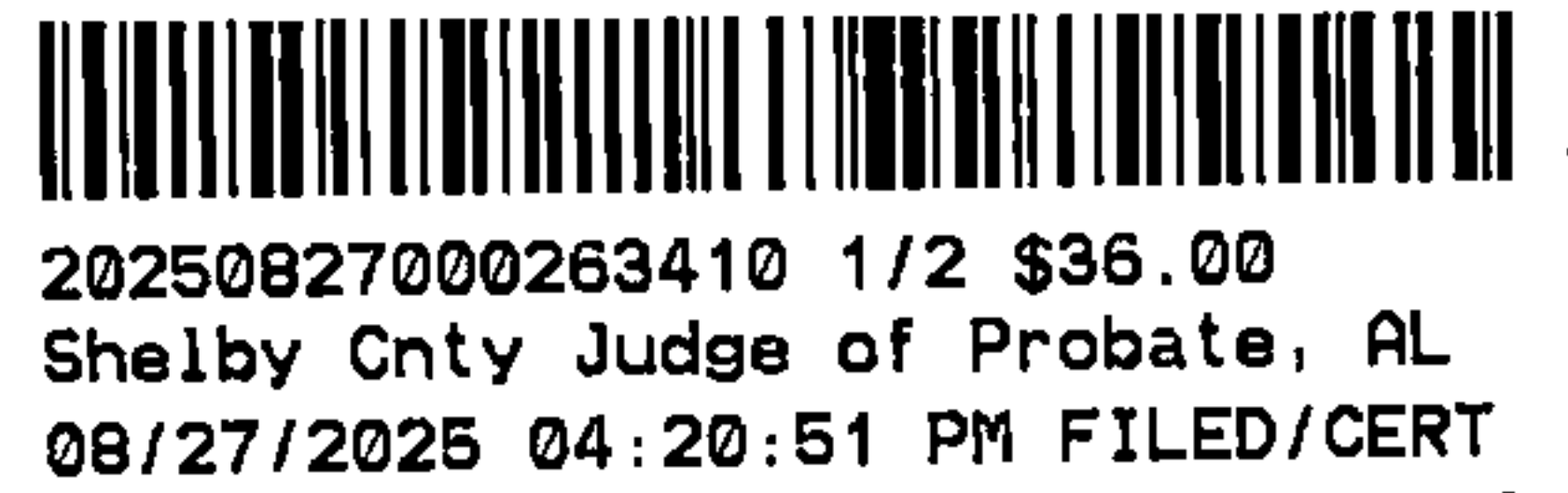

KNOW ALL MEN BY THESE PRESENTS, That in consideration **FIVE THOUSAND SIX HUNDRED AND NO/00 DOLLARS (\$5,600.00)**, and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Brett Davenport and wife, Paula Davenport** (herein referred to as **Grantor**) grant, bargain, sell and convey unto **Hunter White and Haley White, as joint tenants with right of survivorship** (herein referred to as **Grantees**), the following described real estate, situated in: **SHELBY County, Alabama**, to-wit:

2. Easements, restrictions, rights of way, and permits of record.


To satisfy county requirements the grantee is daughter of the grantor herein.
