KNOW ALL MEN BY THESE PRESENTS, That whereas heretofore on August 9, 2007, Sandra D. 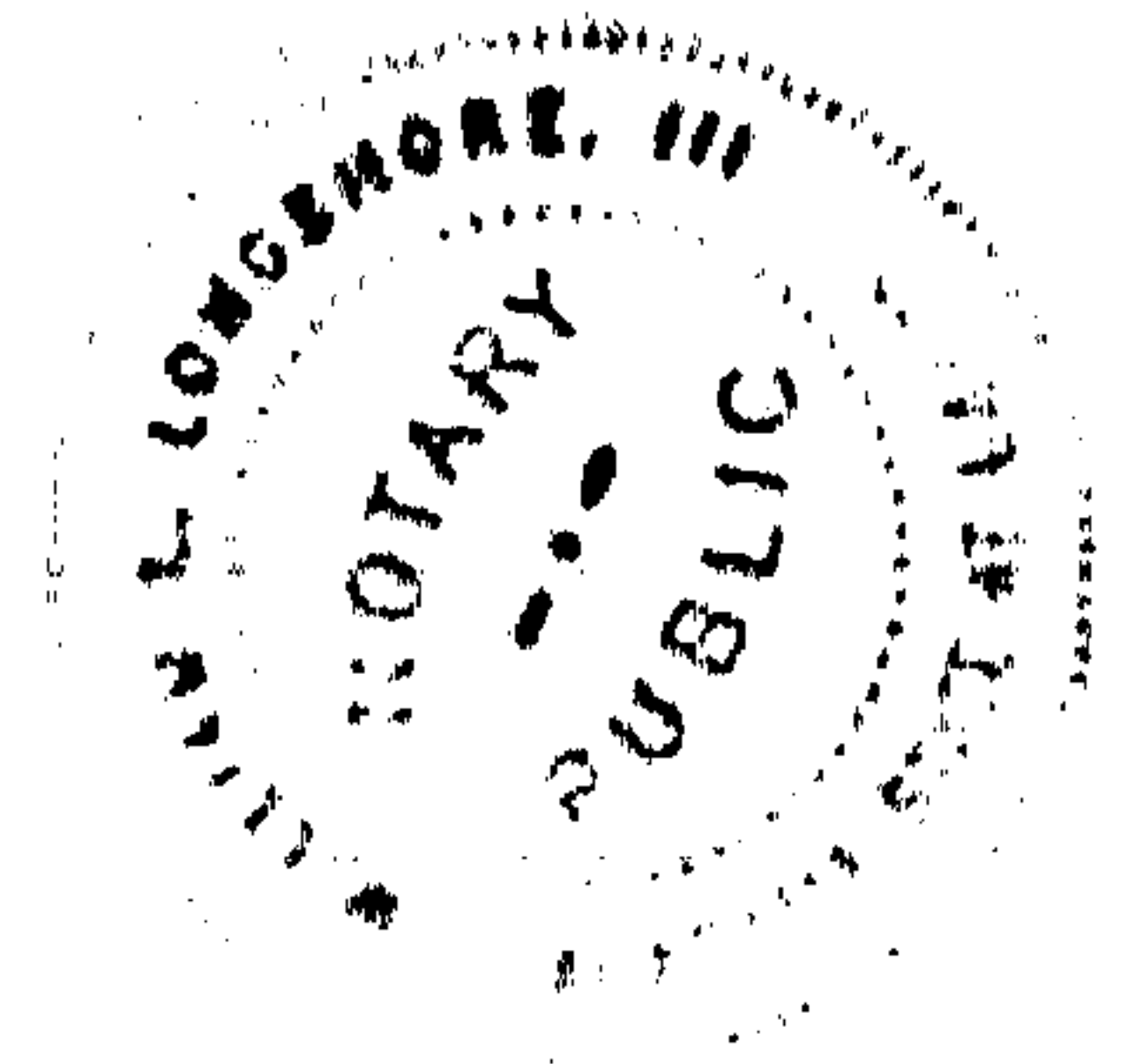
