WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

KNOW ALL MEN BY THESE PRESENTS,

On this August 28, 2025, That for and in consideration of **SEVEN HUNDRED FORTY NINE THOUSAND AND NO/100 (\$749,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **ELIZABETH E. CLARKE, an unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **STEVEN FRANK WINDSOR and BELINDA WINDSOR**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:

Lot 6, according to the Survey of Amended Plat Heatherwood 5th Sector, as recorded in Map Book 41, Page 86, in the Probate Office of Shelby County, Alabama.

Subject to:

1. General and special taxes or assessments for the year 2025 and subsequent years not yet due and payable.-
2. Municipal improvements, taxes, assessments, and fire district dues against subject property, if any.
3. Mineral and mining rights not owned by Grantor.
4. Any applicable zoning ordinances.
5. Easements, encroachments, building set back lines, rights-of-ways as shown of record by recorded plat or other recorded instrument, including any amendments thereto.
6. All matters, facts, easements, restrictions, assessments, covenants, agreements and all other terms and provisions in Map Book 41, Page 86.

Elizabeth E. Clarke is the surviving grantee of deed recorded in Inst. No. 20140103000004240. The other grantee, Roger G. Clarke, having died on or about August 21, 2025.


The purchase of the herein described real property is being financed in whole or in part by the proceeds of a purchase money mortgage being executed simultaneously herewith.



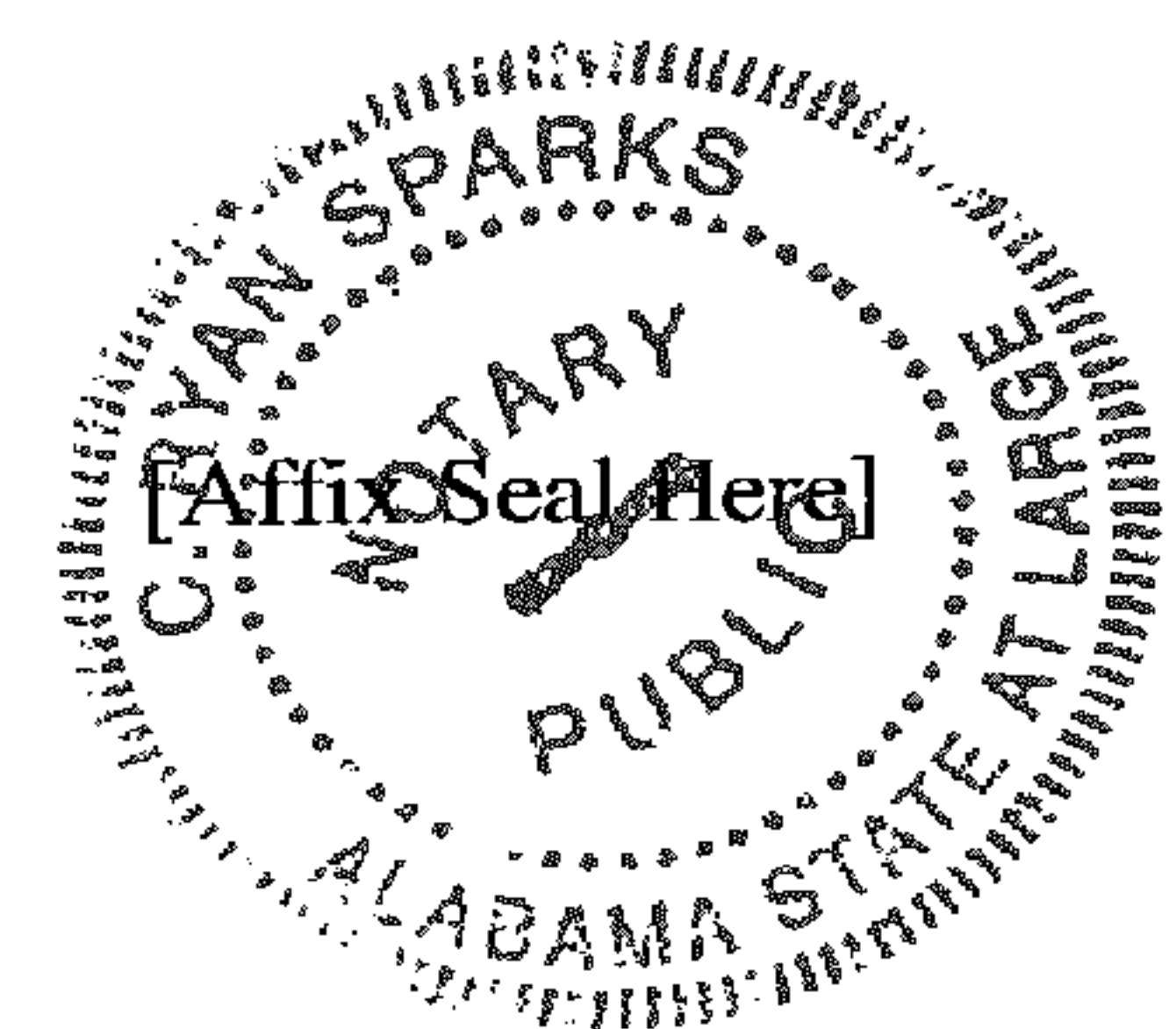

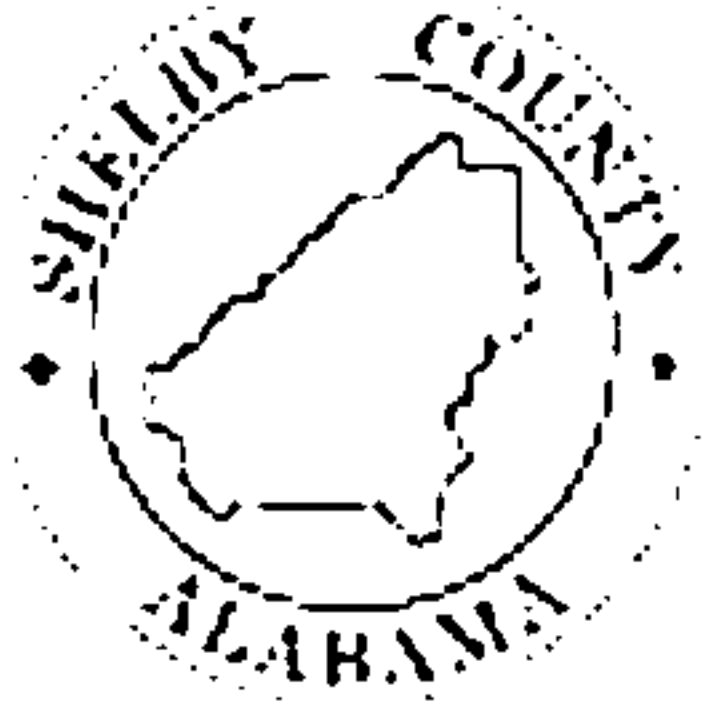
