- (3) To make, do and transact all and every kind of business of what nature or kind soever, including the receipt, recovery, collection, payment, compromise, settlement and adjustment of all accounts, legacies, bequests, interest, dividends, annuities, retirement accounts, life or health insurance funds, demands, debts, taxes and obligations, which may now or hereafter be due, owing, or payable by me or to me;
- (4) To make, endorse, accept, receive, sign, seal, execute, acknowledge and deliver deeds, assignments, agreement, certificates, hypothecations, checks, notes, bonds, vouchers, receipts and such other instruments in writing of whatever kind and nature as may be necessary, convenient, or proper in the premises; to borrow funds, to lend funds, to forgive and collect debts; to create and fund inter vivos trusts and to enter into, execute, and negotiate buy-sell agreements; to complete charitable pledges;
- (5) To deposit and withdraw for the purposes hereof, in either my said attorney's name or my name or jointly in both our names, in or from any banking institution, any funds, negotiable paper, or monies which may come into my said attorney's hands as such attorney or which I now or hereafter may have on deposit or be entitled to, and to have access to any safety deposit box that I may have;
- (6) To institute, prosecute, defend, compromise, arbitrate, and dispose of legal, equitable, or administrative hearings, actions, suits, attachments, arrests, distresses or other proceedings, or otherwise engage in litigation in connection with the premises;
- (7) To act as my attorney or proxy in respect to any stocks, shares, bonds, or other investments, rights or interests, I may now or hereafter hold; to make statutory elections and disclaimers;
- (8) To engage, dismiss and pay agents, counsel, and employees, and to appoint and remove at pleasure any substitute for, or agent of my said attorney, in respect to

- all or any of the matters or things herein mentioned and upon such terms as my attorney shall think fit;
- To prepare, execute and file income and other tax returns, and other (9) governmental reports, applications, requests and documents, and to settle tax disputes, to sign Internal Revenue Service powers of attorney.
