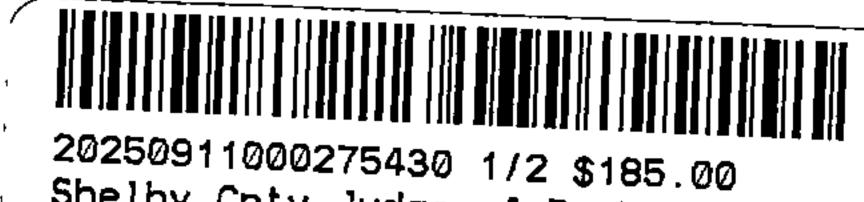

KNOW ALL MEN BY THESE PRESENTS, That in consideration ONE HUNDRED SIXTY THOUSAND AND NO/00 DOLLARS (\$160,000.00), and other good and valuable considerations to the undersigned grantor (whether one or more), in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, Seth Gandy and wife, Jessica Gandy (herein referred to as Grantor) grant, bargain, sell and convey unto Ray Jackson and Joyce Jackson, as joint tenants with right of survivorship (herein referred to as Grantees), the following described real estate, situated in: SHELBY County, Alabama, to-wit:
